A Message from Lodge Secretary, David Naccarato, PER

In our Flag Day ritual, we refer to John Paul Jones, who is known as the Father of the U.S. Navy and who is famous for his much-repeated phrase "I have not yet begun to fight!" General H Ambassad searching was locat to have Jo to the Un 1913, Jon

After the Revolutionary War, he settled in Paris, France, where he lived until his death on July 18, 1792 at age 45. A Frenchman paid 460 Francs to have his body preserved in alcohol and placed in a lead coffin in case the United States ever wanted to claim his body. In 1899 General Horace Porter was appointed Ambassador to France and spent six years searching Paris for Jones' grave, which was located in an old cemetery which had long before been sold and forgotten. President Theodore Roosevelt campaigned to have Jones' body exhumed and returned to the United States, and on January 26, 1913, Jones was buried with full military honors at the U.S. Naval Academy in Annapolis, Maryland, where his crypt remains to this day.

Now here's why I bring it up. Charles Vivian, the founder of the Elks, was also buried twice. Charles was a singer/piano player traveling the country with his act. He had an engagement in Leadville, Colorado where he came down with pneumonia and died March 20, 1880 at the age of 34. His wife said he worked himself to exhaustion bringing joy to everyone he met. Charles Vivian was buried in Leadville, Colorado but nine years later Boston Elks Lodge #10 raised funds and paid to have his body exhumed and transported to the Mount Hope Cemetery in Boston, where he is buried under a suitable headstone that tells his story.
