A Message from Exalted Ruler, Dan Martyn, PER

February brings two important annual lodge events: election of lodge officers and mailing of dues notices.

Our usual means of nominating and electing lodge officers is prescribed by our Grand

Lodge Statutes. Normally we hold a meeting at which nominations are made followed by a second meeting at which the election of officers takes place. This year lodges may be utilizing differing election procedures due to COVID related restrictions affecting each lodge. Those restrictions differ from state to state, county to county and, in some cases, city to city.

Our goal is to utilize procedures designed to afford every member in good standing the opportunity to nominate and vote in the election, adhering to statutory requirements to the greatest extent possible and practical.

The voting procedures for our lodge are set out in the Notice of Voting Procedures included elsewhere in this <u>Antler</u>. Those procedures will also be delivered via email and robocall. We encourage each member to review those procedures and participate in the election process.

Regarding the annual dues notices, given the present COVID restrictions preventing our normal lodge operations and the resulting impact on our finances, we urge each of you to pay your 2021-22 dues by the April 1, 2021 due date. We have heard several members questioning why they should pay dues while the lodge remains closed. Our response is that at initiations, most new members stated that the reason they joined the Elks was to give back to the

community and support our charities. Even though we all miss the fraternal aspect of our membership and hope our lodge reopens soon, the good works of our lodge that you wish to support continue. Since April 1 of last year, in addition to members volunteering, our lodge has contributed \$4,750 to MANNA, \$2,750 to Operation Snowflake supporting needy veterans, \$5,550 to scholarships, \$3,714 to the California Major Project (Purple Pig). \$4,078 to the Elks National Foundation and \$2,500 in Vons gift cards to Senior Concerns and the Blue Star Moms (veterans). The good works of our order continue, so please support our lodge and submit your dues timely.

Some have less restrictions, Ventura County has a lockdown still. The lodge is closed from fraternizing, but it is for your own protection. We wish we could meet twice a month and now we need to nominate Officers for 2021-2022. Dan Martyn will fill us in how that will be handled.

Spanish Flu

One hundred years ago the Spanish Flu as it was called raged on in the battlefields of Europe. Though it will never be clear how it started, it seemed to have started in America's heartland. Fort Riley, Kansas had 100 soldiers diagnosed with the flu. Not knowing much about the spread, when a soldier recovered he was then sent to the front lines in Europe and then we all know the rest. During the war Spain stayed neutral and the flu did not start in Spain. Why the name "Spanish Flu" is a good question. The flu infected 500 million in 4 waves. Even though the Elks were just 60

years old, over 70,000 Elks donned uniforms. A remarkable number when the majority was past military age. More than 1,000 Elks died in this war. Not just from the virus but from battle as well.

Injured soldiers were sent state sides to Camp Devens in Massachusetts where it became apparent that something was amiss. Upon arriving, patients started turning blue from lack of oxygen. Camp Devens is 35 miles from Boston. In one day, 1,543 soldiers were diagnosed with having the flu. Precautions taken then look about the same as precautions we're taking now - masks, shuttering in place, frequent hand washing. One thing they did was wash the inside of their nose both morning and nighttime and force themselves to sneeze to clear out the virus and take brisk walks to stay in physical shape.

Medical communities decided the flu strain was of avian heritage but how it spread to humans they did not know. Kansas is a main migratory path for many bird species and Kansas has many pig farms who may have caught the virus transferred to its meat. The base served pork chops and it's easy to see how it spread. Unfortunately, all that could be done was to let it run its course. In April 1920 it was announced that the flu was over but not until 3% to 5% of the world's population was taken.

Complete Villages on Fiji were wiped out never to return. I said all this to say when asked to wear a mask, do so.

In 1973 the Paris Peace Accord was signed which marked the end of the Vietnam war. On February 12th Operation Homecoming began. Operation Homecoming was the return of 591 POWs held in North Vietnam following the signing of the Peace Accord. One was a Major Fred Cherry who was shot down in an F-105. He was tortured for 93 days and spent 702 days in solitary. Only communication was tapping out messages on the walls of the prison to the other inmates. He was asked to denounce the United States, he did not.

During WW1 The Elks donated 2 million dollars to the war effort. It was raised by members. This figure represented more money from each Elk than it would seem today. These were the days when the \$5 daily wage was still a rarity.

During the 1918 war and pandemic the Elks wanted to help returning soldiers and made 40,000 loans to returning soldiers. All loans, except where death intervened, were repaid. The program was so spectacularly successful the government followed our template and started the GI Loan.

NOTICE OF VOTING PROCEDURES FOR THOUSAND OAKS LODGE 2021-22 OFFICERS

- Positions to be filled by election include Exalted Ruler, Leading Knight, Loyal Knight, Lecturing Knight, Secretary, Treasurer, one-year, two-year, three-year and five-year trustees.
- The present ER will preside over this election. He may not submit any nominations and will not vote in the election but will cast the deciding vote in the event of any tie.
- Any member in good standing may nominate a member to any of the above positions by submitting a nomination in writing to ER Dan Martyn via email to danmartyn2477@aol.com or delivering it to him personally no later than February 10, 2021. The name of the member submitting the nomination must be disclosed.
- All members nominated will be contacted to confirm acceptance of the nomination, and then a sample ballot will be sent via email to all members no later than February 17, 2021. In the event a member does not have email they may pick up a sample ballot at the office.
- The election will take place on Sunday, February 21, 2021 at the lodge between 10 am and 2 pm. Given concerns regarding COVID, we will conduct balloting on a drive-through basis. Members wishing to vote will receive a ballot, complete the ballot and return the ballot to the designated tellers while remaining in their cars. All ballots will be anonymous but will be numbered to prevent duplication.
- Designated tellers will collect and count the ballots and deliver the results to the ER who will announce the results to members via email and robocall.
- In the event COVID restrictions are lifted and meetings are allowed in the lodge, the
 usual voting procedures will be followed, and members will be notified of any such
 change.
