

He then served the Grand Lodge as District Deputy Grand Exalted Ruler in 1992-93. Lee was appointed as the Orange Coast District Leader in 1995 and continues to serve in that position. For his efforts and service to his Lodge, District and Association, his Lodge awarded him an honorary life membership in 1998. Lee has served on

the California-Hawaii Elks Association Government Relations Committee for four years, being the Chairman the last year. He was on the California-Hawaii Elks Association Board of Trustees for three years and has served on the California-Hawaii Elks Major Project Board for two years as Secretary. During this time, he was a member of the California-Hawaii Elks Association Investment Committee for a period of five years. He was President's Achievement Award Chairman for Association President, John Holt in 2000-01. Lee was elected to serve as First Vice President of the California-Hawaii Elks Association for 2003-04.

Lee served his country honorably in the United States Navy. He is a retired Navy veteran, serving on various cruisers, destroyers and staffs from 1956 until his retirement as Chief Petty Officer in November 1974. Lee is a life member of the FVW and also belongs to the Fleet Reserve Association. After his retirement from the U.S. Navy, he was General Sales Manager for Atlas Industries from 1975 to 1978; National Sales Manager for Ambassador Industries, 1980 through 1984, and since that time has been self-employed as an Independent Marketing and Sales Contractor engaged in Government contracts.

Lee has been married to his wife Rosie for 44 years. The have resided in Fullerton, California since 1970 and have four children, two daughters and two sons. Their youngest son, David, is a Past Exalted Ruler of La Habra Lodge No. 2095, and Lee's father, Norm Northcutt, is a long time Treasurer of the Lodge. Lee and Rosie are also the proud grandparents of nine grandchildren.

How is the Elks National Foundation Helping California-Hawaii?

When you give to the Elks National Foundation, you're doing more than funding the Elks National Drug Awareness and "Hoop Shoot" programs. You're doing more than supporting the Elks National Veterans Service Commission and the Elks National Home. You're doing more than providing Emergency Educational Grants to the children of deceased or totally disabled Elks. You're doing more than maintaining the Elks Veterans Memorial. You're doing all that, and you're supporting Elkdom in your state. During the 2003-04 Lodge year, the Elks of California-Hawaii donated \$576,479.07 to the Elks National Foundation. This year, the Foundation will give back the following:

A State Charities Grant of \$341,720.00. The bulk of this grant will go toward your state's major charitable project. But portions will be used to fund your state Drug Awareness, "Hoop Shoot" and Soccer Shoot programs.

A Special Projects Grant of \$346,800.00. We've authorized your state to use this grant to enhance its educational programs, as well as other charitable and philanthropic programs.

A total of at least \$292,000.00 in "Most Valuable Student" scholarships to 73 high school seniors from your state. In addition, we will award 38 Legacy scholarships-a total of \$38,000.00-to children and grandchildren of Elks who have been members for at least two years.

That's a total grant of at least \$1,018,520.00, which represents a ratio of 1.767 for every dollar the Foundation received from your state last year.



Like other things that being an Elk has allowed me to do, I have another to report. What kid does not dream of riding the rails of the mighty Santa Fe railroad. Well, I was given the opportunity of being the engineer of our Elkomotive 2477 Train at the Santa Maria parade. After getting used to towing, I kept thinking at every bump it would fly off the trailer, I was getting into it. I first thought it was a lot of money and a liability. But after taking it up and all the people honking and giving me thumbs up and the kids at the parade in awe looking at our massive train, it was all worth it and would do it again. State Convention now being over and final tallies have come in I would like to report on our Major project fund. The amount of the check that was written by the lodge for Jay to walk across the stage with was \$6800.00. Now that's money collected on the first Wednesday of each month that is put into our gold bucket. Combine a check for \$2000.00 from our Elk ladies organization and \$1000.00 from our Campers group, brought our total to \$9800.00. On account in Fresno was \$2,391.25. Now that is moneys mailed in by you which gave us a total of \$11,716.25 and a per capita of \$22.15. That's the total divided by the membership as of May 14th. With the thousands of miles driven and the high cost of fuel and auto repairs this program needs us more than ever to exist. We've done an excellent job and am confident we will keep it up in the year to follow. Thank you each and everyone for your contributions.

MAJOR PROJECT

Our disabled childrens program that we fund, along with all the Lodges in California and Hawaii had a busy month in March. The therapist that we support had a case load of 425 children with over 1000 visits. They drove 25,094 mile to accomplish their task.

Also the preschool eye screening program saw over 4,383 children and found only 177 children that needed further attention by a doctor. They drove 9,041 miles for this at \$2.33 per gallon and prices going up the program needs our continued support. Which with this lodge it's a given

On Purple Pig Night on May 7th the Elk ladies donated \$2,000.00 to the program and the El Konejo Kampers donated \$1,000. (See Page 11)










2004 Theme Child

Brady Dennington

Brady Dennington represents one of the thousands of children helped each year by the California-Hawaii Elks Major Project, Inc. He is five years old and lives in Hemet with his parents, Sara and Gabe.

Charlene Brown, Regional Manager South, met Brady's grandmother at a scrapbooking class. A conversation ensued and pictures of Brady were shared. Knowing that this family could benefit from our services, Mavis Johnson, Occupational Therapist was contacted. Brady has received occupational therapy in his home setting since February 2002. A diagnosis of cerebral palsy wasn't made until Brady was three years old.

Brady's therapist, Mavis Johnson, remembers Sara sharing the story of Brady's birth. His delivery was traumatic for all of them.

He was delivered by forceps after a very difficult labor. Sara remembers that Brady's head was somewhat mis-shapen when he was delivered and he looked like he was bruised about the face.

At first he seemed stressed and was immediately handed over to the nurses. Their response was somewhat neutral and mom suspected something was wrong but couldn't put a finger on what it was. She waited for someone to reassure her but the answers weren't immediate. It has been a very slow but steady growth process for all—his therapist who wanted to fix everything and help this family understand what their son needed and for his family to understand exactly what his future might involve. Brady's family needed to understand that faced with a great deal of hard work in the coming years they needed to learn how to accept his disability and to be there by his side.

It took several months before his mom and therapist were able to discuss the extent of his disability.

It was a slow and painful process, but without having the Major Project in their home, the working out of these painful feelings of loss and the point of acceptance of the diagnosis of cerebral palsy would have been slower to arrive.

Brady is now five years old and is changing every day. Although he is unable to independently experience a variety of movement experiences due to the increased tone throughout his body, he continues to be motivated to move around the house using a commando crawl. He attempts to get a sitting position himself and he can get safely down from the couch. With adaptations he can sit up in a chair at the kitchen table and feed himself independently. He is working with a communication board to express his wants and needs.

He has just started using a walker and is learning that it isn't as easy as it looks! Brady's needs are being assessed by the school district and he soon will be attending a program that meets his needs for education, physical, occupational and speech therapy. Brady loves country music and exhibits a wonderful playfulness and can be quite the tease. He demonstrates love and gentleness towards the animals in his home and is participating in a therapeutic horseback riding program. The family is pursuing the companion dog program and it is hoped that he will soon receive a dog of his own.

By sharing their son with you as the 2004 Theme Child, his family expresses their grateful thanks to you. They hope that you will continue to be inspired by the results of the help you give to children with disabilities.







AMERICANISM

Raven West, Com. Chair.

Nations come into being in many ways.

Military rebellion, civil strife, acts of heroism, acts of treachery, a thousand greater and lesser clashes between defenders of the old

order and supporters of the new--all these occurrences and more have marked the emergences of new nations, large and small. The birth of our own nation included them all. That birth was unique, not only in the immensity of its later impact on the course of world history and the growth of democracy, but also because so many of the threads in our national history run back through time to come together in one place, in one time, and in one document: the Declaration of Independence.

The clearest call for independence up to the summer of 1776 came in Philadelphia on June 7. On that date in session in the Pennsylvania State House (later Independence Hall), the Continental Congress heard Richard Henry Lee of Virginia read his resolution beginning: "Resolved: That these United Colonies are, and of right ought to be, free and independent States, that they are absolved from all allegiance to the British Crown, and that all political connection between them and the State of Great Britain is, and ought to be, totally dissolved."

The Lee Resolution was an expression of what was already beginning to happen throughout the colonies. When the Second Continental Congress, which was essentially the government of the United States from 1775 to 1788, first met in May 1775, King George III had not replied to the petition for redress of grievances that he had been sent by the First Continental Congress. The Congress gradually took on the responsibilities of a national government. In June 1775 the Congress established the Continental Army as well as a continental currency. By the end of July of that year, it created a post office for the "United Colonies."

In August 1775 a royal proclamation declared that the King's American subjects were "engaged in open and avowed rebellion." Later that year, Parliament passed the American Prohibitory Act, which made all American vessels and cargoes forfeit to the Crown. And in May 1776 the Congress learned that the King had negotiated treaties with German states to hire mercenaries to fight in America. The weight of these actions combined to convince many Americans that the mother country was treating the colonies as a foreign entity.


One by one, the Continental Congress continued to cut the colonies' ties to Britain. The Privateering Resolution, passed in March 1776, allowed the colonists "to fit out armed vessels to cruize [sic] on the enemies of these United Colonies." On April 6, 1776, American ports were opened to commerce with other nations, an action that severed the economic ties fostered by the Navigation Acts. A "Resolution for the Formation of Local Governments" was passed on May 10, 1776.

At the same time, more of the colonists themselves were becoming convinced of the inevitability of independence. Thomas Paine's Common Sense, published in January 1776, was sold by the thousands. By the middle of May 1776, eight colonies had decided that they would support independence. On May 15, 1776, the Virginia Convention passed a resolution that "the delegates appointed to represent this colony in General Congress be instructed to propose to that respectable body to declare the United Colonies free and independent states."

On June 11 consideration of the Lee Resolution was postponed by a vote of seven colonies to five, with New York abstaining. Congress then recessed for 3 weeks. The committee consisted of two New England men, John Adams of Massachusetts and Roger Sherman of Connecticut; two men from the Middle Colonies, Benjamin Franklin of Pennsylvania and Robert R. Livingston of New York; and one southerner, Thomas Jefferson of Virginia.

On July 1, 1776, Congress reconvened. The following day, the Lee Resolution for independence was adopted by 12 of the 13 colonies, New York not voting. Immediately afterward, the Congress began to consider the Declaration. Adams and Franklin had made only a few changes before the committee submitted the document. The discussion in Congress resulted in some alterations and deletions, but the basic document remained Jefferson's. The process of revision continued through all of July 3 and into the late afternoon of July 4. Then, at last, church bells rang out over Philadelphia; the Declaration had been officially adopted.






Elks Care - Elks Share

No one can make us grow except the members, and we are doing exceptionally well so far this year in initiating new Elks. We finished the 03-04 lodge year with a plus 3, and believe me it wasn't easy. We brought in an abundance of new members, but after we counted all of the drops for non-payment, transfers to other lodges, deaths, and absolute dimits, most of our work was for naught. This year we are well ahead of the game, and if the current trend continues 04-05 will end with a great deal more than last year. But our lapsation is still at 71 as of this writing. If you know of any member who has not paid their dues, please convince them to become paid up. On the same token, if you see lapse members in the lodge building, please ask them to either pay their dues or leave. They are taking advantage of what you are paying for.

Included in this months bulletin is a printing of the House Rules. They must be included at least once a year or when changes occur. Since there have been some changes in the operation of the lodge in the past year, there will undoubtedly be some changes coming forth. You'll be kept abreast of these changes as they occur. Bear in mind that all changes to the House Rules and By-Laws must be presented to the lodge and voted upon before Grand Lodge Judiciary approves them. No House Rule or By-Law change will be implemented without your knowledge and approval.

The office staff is going at full speed this time of year. The first 3 or 4 months of every lodge year is maximum confusion and total hyper. Please do not confuse the issue with trivialities that you might be able to take care of yourself. Dee and June (and myself) are spending an enormous amount of time keeping our heads above water right now. The addition of credit

card usage only made the matter worse. Sooo – if you possible can, keep your business with the office to a minimum for another month or so. Of course we are there to help and take care of business, and will do everything possible to accommodate you.

Speaking of credit cards, the program seems to be doing well. You may pay dues, buy drinks and dinners. The bar manager is going to start a file system where if you neglect to pay your bar bill at the end of the evening, she can charge it to your credit account as signature on file. It makes our book keeping much easier and we can close out our daily receipts without badgering you to come down and pay your bar bill. As for checks, we are starting once again to get more of them returned NSF. This also causes us hardships. Bear in mind that the check cashing policy that is posted in the bar is very much in effect. We charge \$5.00 bank fees and \$15.00 for administration fees for every check returned. We also have those who for some reason like to cash one check in the morning with one bartender and then another in the afternoon with another bartender. knowing they do not have funds to cover any of them. That's \$30.00 per day in fees plus their checks. Not very good business practices along with the fact that their check cashing privileges are cancelled. It should also be noted that Elks are totally responsible for their spouses and guests.

Well, I reckon that's about all for this month. Flo and I wish you all a wonderful 4th of July. Wherever you do, and wherever you go, have fun and return safely to us.

THOUSAND OAKS ELKS LODGE #2477 HOUSE RULES

- 1. All details connected with the operation of the clubroom and kitchen are the responsibility of the House Committee.
- 2. The clubroom will be open Monday through Friday from 11:00 a.m. until 2:00 a.m., Saturdays from 9:00 a.m. until 2:00 a.m., and Sundays from 9:00 a.m. until 8:00 p.m. Exceptions to closing to the above can be made by the bar steward at their discretion.
- There will be no other activities in the lodge, clubroom, or on lodge premises during a regular session of the lodge, funeral services of a member of this lodge, or any other special session mandated by Grand Lodge such as Memorial Day or Flag Day Services.
- 4. Escorted ladies and non-Elk visitors accompanied by an Elk will be permitted daily except after 7;30 p.m. on Lodge meeting night. Guests are not permitted access to the lodge or clubroom after 7:30 p.m. on lodge meeting night. Last call must be held at 7:15 p.m. on lodge meeting nights, and 15 minutes prior to those functions described in House Rule #3 above.
- 5. Paid up members in good standing of the Order and their guests are the only persons to be permitted usage of this Lodge facility, except when it is rented or an open meeting declared.
- 6. Visiting members of the Order are required to register and exhibit their membership card to the bar steward.
- 7. Members must buy all drinks for their guests at all times.
- 8. No drinks will be served after 1:45 a.m. and all drinks must be off the bar and tables by 2:00 a.m.
- 9. Loud, rude, boisterous, profane and obscene language is prohibited at all times.
- 10. Any member or guest thereof entering the building while under the influence of intoxicants will not be served or permitted to remain.
- 11. No member shall remove, mutilate or destroy any Lodge property. Malicious or careless damage will be repaired, replaced, or paid for by the person or persons responsible.

- 12. No circulars, notices, or personal advertising shall be posted in the Lodge. Lodge functions may be advertised in the clubroom at the discretion of any lodge officer.
- 13. No tickets are permitted to be sold in the building for any purpose except for Elks functions or activities.
- 14. Minors are not permitted in the clubroom or facilities unless accompanied by a parent or guardian at all times, and must not sit at or be served at the bar.
- 15. No animals will be allowed in the building except seeing eye dogs.
- 16. Political or religious discussions are prohibited in the Lodge.
- 17. Members shall not under any circumstances reprimand or otherwise harass any employee of the Lodge.
- 18. Only the bar manager or duty officer has the authority to correct or otherwise discuss business problems with the bar steward.
- 19. No cigarettes, cigar butts, or other debris shall be deposited on the floors.
- 20. Any member issuing a check with non-sufficient funds will forfeit his club check cashing privileges until said check is made good.
- 21. No member will be allowed to cash a check for more than \$35.00 in any one business day. The only exception being that the member may cash a check for \$35.00 more than his existing daily bar bill. Under no circumstances may a member cash any checks if a check is being held at the bar that has been returned for non-sufficient funds. The maximum amount of a check to be cashed by a visiting member will be limited to \$25.00.
- 22. Any member found guilty of conduct unbecoming an Elk, or violation of any of these rules, may be suspended by the House Committee from privileges of the club in the manner provided by Grand Lodge Statutes and the By-Laws of Thousand Oaks Elks Lodge #2477.
- 23. Under no circumstances will out-of-state, two-party, or un-preprinted checks be cashed at the bar.
- 24. All bar patrons must produce proper valid California identification at the request of the bar steward when cashing checks.

- 25. The bar steward is basically responsible to secure and lock the building when the bar closes. The responsibility can be assumed by any officer of the Lodge if the occasion arises.
- 26. Alcoholic beverages are not to be taken from or consumed outside the building or in the parking lot.
- 27. Alcoholic beverages are not to be mixed in plastic or other take-out containers.
- 28. Drinking of alcoholic beverages behind the bar is not permitted.
- 29. The pool table is to be covered at all social events. No games will be started within one hour prior to the event and there will be no resumption of games until the chairman of the event or duty officer authorizes pool games to resume.
- 30. Bar credit will be calculated on a daily basis, and is due and payable by the member the day credit is established. All bar credit must be paid in full before the member leaves the clubroom for that day, and no further credit will be extended until payment in full is made.
- 31. House Rules will be published in the Antler Antics at least once a year or when a major change is made.
- 32. Any Elk or former Elk who is delinquent, or has been dropped for nonpayment of dues or conduct unbecoming an Elk, from this lodge or any other Lodge, will not be admitted to this lodge or clubroom as a guest of any member of this Lodge, or of any other lodge.
- 33. There will be no smoking by anyone in any food preparation area or in the kitchen at any time.
- 34. No one is allowed to smoke anywhere within the confines of the Lodge building. The only designated smoking areas are the patio or outside the building.
- 35. No one other than the bar steward or bar manager shall be permitted behind the bar at any time unless specifically requested by the bartender or bar manager, and then only to perform cleaning or glass washing tasks as necessary.


