

## ARTICLE FROM GRAND LODGE GOVERNMENT RELATIONS COMMITTEEMAN

The following article is an excerpt from the September, 2004 Grand Lodge Newsletter, and should be passed on to all of our members. This article is written by Grand Lodge Government Relations Committee Member Vincent A. Pingitore, and reinforces the articles that I have occasionally submitted in the past on the subject. Although the elections are over, its value is still important as a tool to reinforce Grand Lodge, State, and local ordinances governing visiting non-members.

"With the elections just months away, now is the time to question your legislators and judges to determine which ones deserve your vote. We all must vote for individual candidates who will preserve our right of free association and enable our great Order to continue its works of charity and aid to humanity, while allowing our Lodges to remain truly private organizations.

One way that we, as individuals, can help to protect our "private" status" is to enforce a "closed-door policy" at our local Lodges. Challenging everyone who enters, making all guests sign the guest book, not allowing guests to buy drinks, and other such methods, while they might seem overly burdensome, will ensure that your Lodge will not be labeled with the designation of "place of public accommodation," rather than "private organization."

Many states, as well as the federal government, have created an exemption from the definition of "place of public accommodation" for bona fide clubs which are distinctly private in nature. You should be familiar with the requirements of your state or locality as to what constitutes a private organization. Recently, the Supreme Court of Vermont issued a ruling which was devastating to a local Lodge and sends a warning to all Lodges in our Order! The court stated "Courts have commonly applied and weighed several factors to determine whether a club is private or public including: a) whether the group's membership is genuinely selective; b) the amount of control the existing members have over the club's operations; c) the history of the organization; d) the use of club facilities by non-members; e) whether the organization advertises or directs its publicity to anyone other than members; f) the purpose of the organization; and g) any profit motive, "along with: "the selectiveness of the group in the membership procurement program, offered incentives, such as watches, cruises and free dinners, that the Lodge had no limit on the number of members it allowed, and that the lodge accepted 99.3% of all applicants as members, the Lodge was not truly selective in nature, and therefore did not meet the criteria for a "private organization."

The only way to prevent all of our Lodges from meeting the same fate is to elect individuals who are sympathetic to our rights as private organizations, and to enforce the "closed door" policy at our Lodges. Members, the tide is turning against us, so we should look to protecting our right of selectivity by initiating members who share our common values, belief in God, and are of good moral character. Only then will we be able to continue the great traditions of Elkdom in our communities and prove that "Elks Care - Elks Share."



Our goal is to raise \$200,000.00 (in a very short time) so we can proceed towards getting the loan for our New Lodge. The funds can be from fundraisers or even purchasing more bonds. #### How is the Elks National Foundation Helping California-Hawaii?

When you give to the Elks National Foundation, you're doing more than funding the Elks National Drug Awareness and "Hoop Shoot" programs. You're doing more than supporting the Elks National Veterans Service Commission and the Elks National Home. You're doing more than providing Emergency Educational Grants to the children of deceased or totally disabled Elks. You're doing more than maintaining the Elks Veterans Memorial.

A Special Projects Grant of \$346,800.00. We've authorized your state to use this grant to enhance its educational programs, as well as other charitable and philanthropic programs.

A total of at least \$292,000.00 in "Most Valuable Student" scholarships to 73 high school seniors from your state. (Click here to check out your recipients.) In addition, we will award 38 Legacy scholarships-a total of \$38,000.00-to children and grandchildren of Elks who have been members for at least two years. (Click here to check out your recipients.) That's a total grant of at least \$1,018,520.00, which represents a ratio of 1.767 for every dollar the Foundation received from your state last year.

And if you'd like to know what the Elks National Foundation has done for California-Hawaii in the past, since inception in 1928 through March 31, 2004, the Foundation has granted a total of \$23,985,923.97 to your state, compared with your state's total donations of \$22,312,061.43. At the Grand Lodge Convention in 1961 at Miami Beach, the committee on Americanism was created and charged with "imple-

menting the patriotic activities of the Order and its subordinate Lodges."

The creation of the Elks Americanism Committee in 1961 met an important need in a critical time in our history. The Committee provided our Lodges with constructive and definite programs for strengthening the spirit of American patriotism in their communities, and vigorously promoting their use. The response of our Lodges was both prompt and enthusiastic, and the result has been a tremendous expansion in the Order's patriotic activities... and a major contribution to the security of this nation.

Our Government has, time and again, enlisted the aid of the Order in patriotic undertakings where civilian cooperation was deemed essential.

Membership in the Order of Elks is a "badge of citizenship", for none but an American can be an Elk. "Love of Country, home and Mind" are its principal tenets, and our country's flag is raised in silken benediction over the Altar of every Elks Lodge.

With its all pervading spirit of good will, the Order makes an irresistible appeal to men and women who deeply love their country, cherish fraternal association, and welcome an opportunity to serve their communities

As Americanism Chair it is my honor and privilege to host the annual Elks National Americanism Essay Contest.

The theme of this year's essay was "What Does OLD GLORY Mean To Me". I received over 130 entries from five schools in the Conejo Valley area. Judging these essays are very difficult and with a 200 word limit, a great deal has to be expressed in a very limited space. The contest is judged in two Divisions: I - 5th and 6th grades and II - 7th and 8th grades.

First, second and third place winners in each Division will receive a United States Savings bond which will be presented at our Youth Awards banquet in May. First Place winners in both divisions receive \$300 bond, Second Place receives a \$200 bond and the Third Place receives a \$100 bond, plus a beautiful plaque engraved by Joe Smith and an awards certificate. In 2003 Thousand Oaks Lodge #2477's Division II winner also won first place in our District!

The First Place winners of each Division will go on to compete at the District level, then on to the State competition, and the final competition will be at the Elks National Convention.

Winning essays will be published in next month's Antler Antics.

#### **CONSTRUCTION UPDATE**





We are all anxious to get our new lodge building started and everything is now in place with one exception. Yes, we are still short of funds. After going over financial operations of the lodge, both past and future, it is apparent that we need to raise an additional \$200,000 before we go out and borrow the balance required to build. We do have several offers to loan us the additional funds but we are concerned with our ability to make the payments each month for the next 30 years. In addition, each of the financing options we have looked at will require us to refinance after 3 or 5 years. The additional \$200,000 we need to raise will insure we are in a stable financial position when the time comes to renegotiate the loan.

With that said, here is what we are planning to do to raise the additional funds:

- A new appeal for our members and associates to purchase bonds is going out. Bonds are still being purchased but we need to turn up the heat a bit to finance this project as much as possible from within our own lodge.
- A group is being formed to concentrate only on raising money for our new facilities fund. This group will not be concerned with bonds but with appealing to local businesses to support our efforts.
- · Naming opportunities will be available to corporate or individual sponsors so that their names will be visible to all that enter our new lodge.
- The fund raising group will also be putting together events such as golf tournaments, bowling events and raffles/games that will be devoted to building up our new facilities fund.

What we need from each member is your support. The faster we raise this money, the sooner we can break ground. I don't need to remind you that our building costs are rising every day. Please, buy bonds. Support the fund raising efforts and help us move this project off of paper and into the construction phase.

#### **GOVERNMEMENT RELATIONS**

Back in December, the US Supreme Court announced that it
would accept the cases involving the issue of the
government's public display of the Ten Commandments due
to the inconsistent rulings by various state courts. Interestingly, a number of these cases involve the Fraternal Order of
Eagles, a private organization, whose mission is to make
human life more desirable by lessening its ills, and by
promoting peace, prosperity, gladness and hope; and whose
motto is "People Helping People." They raise millions of
dollars each year to combat heart disease and cancer, aid
disabled children and the aged. In the 1950's and 1960's,
local Eagle Orders donated monuments to municipalities as
a nationwide practice.

A number of these monuments still stand today, approximately 6' x 3 ½' size. A large panel displays a nonsectarian version of the text of the Ten Commandments. Above are two small tablets of ancient Hebrew script, an American Eagle grasping the American flag, and an eye inside a pyramid closely resembling the symbol on the \$1 bill. Below the text are two small Stars of David, as well as a symbol representing Christ, and two Greek letters, Chi and Rho. Below that is an inscription of dedication.

These monuments have been standing for decades, and now, with the religious sensitivity in recent history, lawsuits have surfaced involving government violation of the First Amendment. In order for a display to survive the constitutional challenge, the court uses a three-part Lemon test, whereby the display must have a secular purpose and that a reasonable observer would not view the display as establishing, endorsing, aiding, or otherwise be an excessive entanglement with religion.

Here are just two cases involving the Fraternal Order of Eagles that show the differences in court analysis and outcomes.

#### Van Orden v. Perry, 5th Circuit--Texas


The monument challenged as described above has the inscription, "Presented to the People and Youth of Texas by the Fraternal Order of Eagles of Texas 1961." Plaintiff Van Orden filed suit that such a display was an advancement and endorsement of religion favoring the Jewish and Christian faiths, in violation of the First Amendment.

The Court found that the monument was secular in purpose, as it was a commemorative display of significant events of Texas history, as well as an expression of appreciation for the work of the Eagles with the American youth. Further, a reasonable observer would not find the display to convey that a religious belief was being favored or preferred, since the State Capitol was declared a national historical landmark, and it has 16 other monuments on its grounds, the array of monuments depicting both the secular and religious history of Texas from a historical standpoint. The Court ruled the display was not in violation of the First Amendment.

This next case is more interesting, as the governmental entity creatively attempted to make a First Amendment challenge moot by selling the land on which the monument stands to a private party, to which the First Amendment Lemon tests would not be applicable.

#### Mercier v. City of La Crosse, 7th Circuit--Wisconsin

The City of La Crosse placed the donated monument by the Eagles in a public park with no other monuments. After the lawsuit was filed, the City then sold the monument and a 20' x 22' plot of land surrounding it back to the Eagles, who then fenced the parcel and placed signs on each side indicating that the parcel was now privately owned. The Eagles argued that the purpose in donating the monument was to preserve the moral and religious heritage of the United



The court found that unlike Van Orden, where the monument was part of a larger display with an overall secular message, the monument in this case was by itself in a public park and was sufficient to create a perception of endorsement from the standpoint of a reasonable observer. Therefore, the Court would have to infer a religious purpose unless the government takes proactive measures to show that its purpose was secular. Further, the City had the burden to show

it took steps to obviate the monument's religious purpose, but did nothing to diminish the monument's religious character.

With regard to the sale of the land, the court found that the only purpose of the sale by the City was to maintain the location and preserve this "religious message" in a public park. The City had alternatives to sale of the land, including an offer to move the monument, but chose to approach and sell the land to the Eagles. The court reasoned that the sale was invalidated by the violation the Establishment Clause and upheld the prior ruling for the monument to be removed.


#### Conclusion

There are number of cases involving monuments with religious overtones. Research did not reveal any of them being donated by Elk lodges, but should there be any with a biblical display, they could be brought to Constitutional challenge.


Each monument is judged on a case-by-case basis. For the most part, monuments found to be "historical" in nature can still stand. It will be very interesting how the US Supreme Court will analyze the issue of whether the sale of land of a monument to a private organization eliminates the government establishment or endorsement of religion; and whether, in the absence of a historical display, the court must make an automatic inference of religious purpose whereby the governmental entity has to take sufficient steps to secularize the monument in order to display it.

These issues are scheduled to be heard in March of this year, with Opinions to issue months later. Favorably, Justice Rehnquist still retains his position on the bench. Although physically challenged, he is active and keeping up with writing opinions.








