

IN THE BEGINNING

Ever wonder how the Elks started well I'm going to tell you. Charles A. Vivian was a twenty five year old singer from England who arrived in New York on November 15 1867. He attained some measure of success as a variety performer. He also struck up a large and boisterous number of acquaintances in the performing world, the nucleus of what would become the Elks

Vivian's friends were soon known as the Jolly Corks due to a cork trick that they used to initiate new members into their group. At a Meeting held February 2nd 1868 presided over by Charles A. Vivian a motion was made to organize "the Jolly Corks" as a lodge along benevolent and fraternal lines and providing that a committee be appointed to formulate rules and regulations for its government, prepare a suitable ritual, and select a new name.

Why was the Elk adopted as the symbol of the order? The 15 founders of the fraternity desired a readily identifiable creature of stature, indigenous to America. Eight members voted to adopt the elk, and seven favored the buffalo.

SIDE NOTE

Shortly before Christmas in 1867, only a few months after the fellows began to meet, one of their number died, leaving his wife and children destitute. This event gave rise to the notion that, in addition to good fellowship, The Jolly Corks needed a more noble purpose in order to endure, and serving not only their own need, but others as well, would be appropriate.

Two months later, with a statement of purpose, and impressive set of rituals, a symbol of strength and majesty and such other elaborate trappings that might be expected of a group of actors and musicians, the new fraternal order was launched. The growth and record of benevolence of the Elks is well chronicled, with Elks lodges now in 2200 communities and a membership up near 1 million Americans.

NEW FACILITIESGregMetzgus, PER



Five bids for our new building were turned into the lodge office on the 31st of January by general contractors in our area. The bids all came in at or near what we had predicted; between \$1.6 million and \$1.8 million. Because the article is being written on the 2nd of February, it is too early to have had time to fully evaluate all of the bids. There will have to be a lot of value engineering (finding ways to lower the cost) and cost adjusting (including all of the permit fees, kitchen equipment etc) before we will know the exact cost. One thing that is clear now, we can build a new lodge building for the amount of money we had predicted.

The Steering Committee will meet again this Monday and as often as necessary there after until we have a completed building cost package to present to the Exalted Ruler, membership and the Trustees. The high budget figure of \$1.8 million is the number we are going to have to come in at. Some things will have to be trimmed to meet that budget and some of the work will have to be accomplished by members. Two of the general contractors we have talked to are willing to work with our members to help make this project affordable. Examples of things our members can do to help build the lodge are tasks like the sprinkler system installation, landscape planting, appliance installation, and maybe even a little painting. The major portions of the construction are best left to the professionals but if you are a licensed tradesman and would like to submit a proposal to the successful contractor, don't wait till he has already given the sub-contract to someone else.

Another way we can bring the initial cost of the project down is to forego some of the construction until a later date. The city is requiring the 2nd story for aesthetic reasons but the finishing of that area is costly. We can leave the 2nd floor unfinished and defer the cost of air conditioning, plumbing and, painting and carpeting upstairs to a later date. Sure, we all want it now but it is possible to have a new hall, lodge room and lounge now and complete the 2nd floor later.

Several of the major items we will eventually need can also be the focus of specific fund raisers between the time we start construction and when those items are actually needed for installation. The room divider is a major item; \$25K plus or minus. The new kitchen equipment we need is something that we would need to

install at the completion of the project. These are just two items that we can focus on financing while our new lodge is being built. Most of us with children have preached to them that if you want something, you will have to be patient and work for it. This is an opportunity for us to practice what we preach.

In closing, let me remind everyone that commercial financing of this project is a very costly portion of the work. All of the bank's finance fees are money we have to pay and we get nothing but a piece of paper in return. Many members have stated that once they see a shovel in the ground that they will jump on board and help. We need a commitment now from our members so that we can put the shovel in the ground. Every dollar we save in finance fees is money we can put into our building instead of the pockets of some banker. Our building bond's interest rate is very attractive and many of our members have reaped the benefits in the form of interest checks. Our lodge would much rather pay our members interest than to pay a bank. In short, buy bonds and buy often.

INVOICES FOR 2007-20008 MEMBERSHIP DUES ARE IN THE MAIL

As was the case this past year, the annual dues of \$241.50(\$225.00 dues plus G.L. & CHEA assessments of \$16.50) may be split into two equal payments of \$120.75.

The first payment is due no later than April 1, 2007. The second payment is due no later than October 1, 2007. G.L.Statues require that any member who has not paid his or her dues is considered lapsed and prohibited entry or use of Lodge Facilities.

A member who only pays one-half is considered lapsed as of October 1, 2007 and is eligible to be dropped between October 1, 2007 and March 31,2008. A member who has not paid any dues after April 1, 2007 is considered lapsed and can be dropped anytime after October 1, 2007.

Only paid up members can be granted Absolute or Transfer Demits. "Accomplishment Stickers" will only be applied to memberships cards that are paid in full.

Special door cards will again be used for one-half and fully paid members.
