

Our Legacy to the Future

Seventy-five years ago, at the Grand Lodge Convention in Miami, the delegates voted to establish an Elks National Foundation. They were compelled to action by the words of then-GER John F. Malley, who described the Foundation as "an Elk temple of philanthropy, which, in time, will be the greatest monument to a noble purpose that has ever been built by a fraternal organization." The idea of an Elks Charitable Trust was first introduced by Malley during a banquet at Meriden, Connecticut, Lodge on February 21, 1927. His plan called for the creation of a fund, fueled completely by voluntary donations.

His dream became a reality the following year, at the 1928 convention. The Grand Lodge got the ball rolling with an initial \$100,000 grant. A second \$100,000 grant soon followed. In that first year, Elks, their families and friends raised a total of \$52,500.

Since then, the ENF has relied on volunteers at the Lodge. district and state levels to help coordinate our fundraising strategy. These dedicated individuals reach every Elk family by hosting fundraising events, promoting the Foundation and personally inviting members to pledge their support. With more than 183,000 active donors, the Foundation has raised a total of more than \$147 million since inception.

All donations go into a permanent endowment fund, where each gift earns interest for lifetimes. Only the income earned by this fund can be used to support charitable programs. (Capital gains and appreciation are considered principal, not income, and therefore cannot be spent.) Today, the value of this Endowment Fund is over \$320 million

In February 1931, the Foundation Trustees felt that the time had come to begin using that income to foster and further the Elks' philanthropic causes. They believed the fund should supplement the work being performed by the various Lodges and State Associations.

Today, the Elks National Foundation has distributed more than \$217 million in support of Elks charitable activities nationwide. During 2007-2008, the Elks National Foundation will distribute more than \$14.8 million through college scholarship programs, the Elks Drug Awareness Program, the Elks National "Hoop Shoot" Free Throw Program, the Elks Soccer Shoot, the Elks National Veterans S ervice Commission and the Elks National Home.

The Foundation also strives to give back to each state more money for its charitable programs than that state donated to the Foundation.

A board of seven trustees, who are all past national presidents of the Order, administers the Elks National Foundation. The Foundation is located at the Elks national headquarters in the Elks Veterans Memorial in Chicago. The current director, Jim O'Kelley, oversees the administration of the Foundation's day-to-day operations. He has a staff of 14.

Through continuous support, the Elks National Foundation hopes to expand its services to others through college scholarships, veterans service, drug educational and youth athletic programs, and charitable grants to state Elks associations

THEY SHOOT, THEY SCORE

Las Vegas to Host Elks "Hoop Shoot" Free Throw West Regional Championship Saturday, March 3 rd, at Hyde Park Middle School 10:00 A.M.

On March 3 rd, young free-throw shooters hailing from Nevada, California, Hawaii, Utah, and Arizona will descend on Las Vegas, Nevada, to display their impressive skills as they compete in the regional championship of the Elks "Hoop Shoot" National Free Throw Contest. These net-stuffing boys and girls, who already have a local, district, and state championship under the belts of their warm-up suits, face their next challenge here in Las Vegas. With free-throw percentages that would make many in the NBA weep with envy, these talented youngsters have already proven themselves to be the standouts in a competition that started last fall with more than 3 million participants, ages 8 to 13. Now as the top free-throw shooters from five states gather at Hyde Park Middle School, they will continue to make news as they take all their hard work, talent, and concentration to the line. At stake is a chance to advance to the national finals, where just 72 participants will compete April 19-22, 2007 at the birthplace of basketball, Springfield, Massachusetts. Now in its 35 th year, the Elks "Hoop Shoot" National Free Throw Contest, sponsored by the Benevolent and Protective Order of Elks, has grown into the largest coeducational sports program in the country, allowing boys and girls to compete separately in three age-groups, 8-9, 10-11, and 12-13. Each contest consists of 25 free throws—10 in round one, 15 in round two—with ties being resolved in five-shot shoot-offs. The six regional winners from the competition at Las Vegas will have a chance to stake their claim to one of six coveted spots on the Elks "Hoop Shoot" plaque in the Naismith Memorial Basketball Hall of Fame alongside the likes of past Elks "Hoop Shoot" champs and sports luminaries as Indiana Pacer Chris Mullin, former North Carolina State star Jennifer Howard, and former Chicago White Sox third-baseman Chris Snopek. The Elks "Hoop Shoot" National Free Throw Contest is entirely funded by the Elks National Foundation, the charitable arm of the Benevolent and Protective Order of Elks. Last year, the Foundation disbursed more than \$13.1 million in support of youth programs, veterans services, drug education programs, college scholarships, and aid to people with disabilities.

The Benevolent and Protective Order of Elks of the United States of America is a patriotic and philanthropic fraternal organization with nearly 1.2 million members in more than 2,200 communities.

HISTORY OF THE ELKS NATIONAL HOME

In 1902, The Benevolent & Protective Order of Elks purchased the Hotel Bedford in a bankruptcy sale. The Elks National Home was dedicated May 21, 1903 with over 5,000 Elks from around the country in attendance. In the beginning, the Home was established for "indigent" Elks and they were supported by their subordinate lodges and the Grand Lodge. Today, although the Home is supported in part by the membership through the \$1.00 annual assessment, the residents are financially self-sustaining and pay the charges established by the Board of Grand Trustees. Their subordinate lodges are not responsible forany charges

After a few years, the old hotel building became inadequate for the increasing residency. The cornerstone for a new home was laid in September 1915 and the new home was dedicated July 8, 1916. Between 1923 and 1938, three additional buildings for residents were constructed, as well as a laundry building and theater. In 1985, Building "A" was totally renovated to provide private bathrooms and central air conditioning. The renovation of Buildings "B" and "C" followed in 1987 and 1991.

The first female Elk members became residents in 1999 and a major renovation project began. The project involved converting four buildings into apartments for independent living, a complete renovation of the lobby, a dramatic redecoration of the dining room and sun porch, and enclosing the verandahs that connect the buildings at the front of the Home.

As in the past, I am writing this article before a crucial vote concerning our new lodge has been taken. This is necessary to meet the deadline for publication in the April Antler Antics. It was moved and seconded to lower dues and by Grand Lodge Statutes, our members will be voting on the 14th of March concerning that matter.

Just to refresh your memory, the dues were raised last year to help us have the ability to service (pay back) the loan required to build. Of the increased dues, \$120 was to be put into a fund to be used only for the mortgage. We have been doing just that for the past year. When we apply for a loan, the bank will insist on seeing our plans for paying it back. The idea of the increased dues was to help improve our overall bottom line and lessen the burden of paying the mortgage each month.

Now with the possibility that the dues will be lowered, it is very difficult to predict what will happen with our new lodge project. If the dues are lowered, it will make it impossible to borrow the money required to build. If the members voted on the 14th of March to lower the dues, there is no way our new facility can be built and it isn't necessary to read any further than the period at the end of this sentence.

Hopefully, you are all still reading. Now we need to attack the financial problems we have left and get a shovel in the ground. There is only one thing left that is required to start building, a commitment for new members, about 400 of them would do the trick. If you are finished gasping, I will go on.

The cost to build is in the neighborhood of \$1.8 million. There will be future meetings to go over all of the figures they are far too involved to cover in this article. We are not trying to fool anyone, we know there will be extra costs involved and we will have to put in a percentage to cover that inevitability. This may raise our costs towards the \$2 million dollar mark. But, with the revenue we plan to generate with the new building from rentals and the proposed new members, the numbers will work. It is a difficult task but to this point in the project, everything has been difficult, why should anything be easy now?

I believe in this lodge. I also believe we should all look to the future. We all enjoy our lodge and belong for a wide variety of reasons. Some just want a watering hole

and good company. That is fine but, that will not insure the perpetuation of our lodge. Good business practices will. It is getting more and more difficult to attract members and it will continue to be that way as we watch the rest of the world go by. Potential members have many choices when it comes to being involved with the community. We need curb appeal. Once we get them in, give them something to do and someplace to go, they will bring in others. We saw it happen 2 years ago at Atascadero Lodge #2733.

To recruit 400 new members, we need to give them something more than a promise of a new building. *We need to break ground now*. This would be foolish on our part unless......unless we had a commitment from our present members that we would have 400 new members within the next 18 months. That is about one new member for every member we have now. I know, some will be unable or unwilling to help in this endeavor; that means some of us will have to recruit more than one. Trying to recruit that many new members before we actually start building would be impossible. Recruiting that many members as the building is going up is possible if we all work together.

I am in hopes that the last 4 paragraphs were read. A new lodge will bring us into the 21st century and insure we have a place to go in the future. What is really needed now is for the lodge to move ahead in one direction. That direction will have been established by the time you have read this; after the vote on the 14th of March.






