Several meetings ago, the question came up in regards to the funds generated by the Past Exalted Ruler Association's BBQ, which they run approximately 5 times a year, (when ever there are 5 Saturdays in a month). Although it was not intended as a rebuke or accusation, some members present at the time took it to mean that the PER's were using these funds for purposes, which may not be in the best interest to the Lodge. To any member who has questions on this subject, I first would suggest to him or her to re-acquaint themselves with Section 13.190 of the Grand Lodge Statutes.

The PER Association members are the advisers and counselors to all officers of the Lodge as well as the various committees, BUTwith emphasis on aiding the Exalted Ruler. As to the funds generated by various activities of the P.E.R.'s, they are used only for the direct benefit of the Lodge, and are accounted for every year by the general audit. For the past four years, several thousand dollars in bonds have been purchased to show support of the efforts to build the new Lodge and to set an example to the general membership. The yearly interest on the bonds is donated back to the Major Projects and E.N.F.



ELKS NATIONAL FOUNDATIONFAST FACTS

1. What is the Elks National Foundation?

With a grant of \$100,000, the Elks National Foundation was established in 1928 as the charitable arm of the Benevolent and Protective Order of Elks of the United States of America. Today, the Foundation has a market value of more than \$320 million. The Foundation is a public, nonprofit, tax-exempt corporation as described in Section 501(c)(3) of the Tax Reform Act of 1959. Donations to the Foundation are deductible for federal income and estate tax purposes.

2. What is the mission of the Elks National Foundation?

The Elks National Foundation's mission is "helping Elks build stronger communities." We do this by providing tomorrow's leaders, our youth, with a healthy beginning; honoring the Elks' pledge that, "So long as there are veterans, the Benevolent and Protective Order of Elks will never forget them"; and helping the state Elks associations accomplish their charitable objectives.

3. How is the Foundation administered?

The Elks National Foundation is administered by a board of trustees composed of seven past national presidents of the BPO Elks of the USA, each serving a seven-year term. A director who reports to the board oversees day-to-day operations of the administrative offices in Chicago. 4. Who contributes to the Elks National Foundation? Since inception in 1928, the Foundation has received more than \$147 million in contributions from Elks and their families. These donations go directly into the Foundation's endowment fund, where they are never touched; only income from the fund is expended. Contributions are currently coming in at a rate of about \$5 million a year.

5. Who pays the Foundation's operating expenses?

The Foundation has an operating budget of \$1,298,785.These expenses are borne by the Foundation.6. How much will the Foundation disburse this year?The Elks National Foundation will disburse more than \$14.8

million during the 2007-08 year.

* How will this money be used?

* Scholarships. The Foundation has budgeted a total of \$3.162 million for its five scholarship programs: The "Most Valuable Student" scholarship contest(\$2.216 million); Emergency Educational Grants for children of deceased or totally incapacitated Elks (\$350,000); ENF Legacy Awards (\$500,000); Eagle Scout Scholarships (\$48,000); and Girl Scout Gold Award scholarships (\$48,000).

* State Elks Association grants. The Foundation will distribute \$4.512 million in state charities grants. This includes a bonus grant of \$1.5 million. These grants help fund each state's major charitable project, as well as fund state "Hoop Shoot," Soccer Shoot and Drug Awareness Programs. In addition, the states received more than \$2.24 million in special charitable project grants that help fund scholarship programs or other projects that will best extend a state's philanthropic outreach.

* Drug Prevention. The Foundation budgeted \$547,000 for the Elks Drug Awareness Program.

* Veterans Service. The Foundation granted \$722,000 to help fund the Elks National Veterans Service program.

* Youth Athletics. The Foundation granted \$585,000 to fund the Elks "Hoop Shoot" free throw contest, in which more than three million kids will participate. ENF also approved a grant of \$148,000 for the Elks Soccer Shoot program.

* Elks National Home. The Foundation granted \$715,000 to the Elks National Home, a retirement facility for Elks located in Bedford, Virginia.

* Elks Veterans Memorial Maintenance. The Foundation granted \$484,770 for building maintenance. In addition, a grant of \$250,000 was approved to the Foundation's Elks Veterans Memorial Maintenance Reserve Fund.

8. What are the Foundation's primary giving methods?

* Pledge: The most popular way to support the Foundation is through a pledge. A donor can choose to receive a pledge reminder annually, semi-annually, quarterly or monthly.

* "Non-pledge" Donation: If a donor does not wish to receive pledge reminders, the donor can make a "non-pledge" donation.

* Matching Gift: Many employers will match gifts given to charitable organizations by employees and their spouses, even if they're retired. Check with your company's H.R. office to find out if it sponsors a matching gift program.

* Tributes: Donors may contribute to the Foundation in memory of or in honor of friends and loved ones, online or through the mail.

* Planned Gift: Planned gifts can include bequests and gifts of appreciated stock or life insurance. More information about planned giving is available online at www.elks.org/enf/malleysociety.cfm.

* Online Giving: You can now support the ENF at any time of day from the convenience of your own home. To make your gift, go to www.elks.org/donate.

He was truly a medical miracle worker, patients after being provided with a thrilling ride to the hospital and after being removed from the ambulance would suddenly jump off the gurney and dissappear into the night without the slightest need for additional medical intervention. don't know how he did it, a miracle, maybe?

Our Elk of the Year also spent several productive years at various dispatch centers through out the city. About 1,000 to 1,500 dispatches a day was not unusual. This provided a unique opportunity for our Elk of the Year who thoroghly enjoys telling people where to go and how to get there. After 31 years in the Fire Department. he retired August 3rd 1996. I was told the department will never be quite the same but it was better while he was there. Our Elk of the Year joined the Elks February 2002 and his sponsor was Roy Cooper, Johnny D'Amrogio was the Exalted Ruler. This Elk of the Year has alway embodied the Elks motto 'Elks Care and Share'. Has always been there to help and will work to the very end. As a fireman and friend William K. Maxwell is our Elk of the Year 2006-2007 member #1968.

The Inaugural Ball was a tremendous success and everyone seemed to enjoy the event. The band was entertaining as always and Catherine's singing was the highlight of the gala. There were some unfortunate mishaps in the kitchen, but they did their best to overcome them. The Escarole tasted a little like Salmon, and the cooking procedures for the chicken could use some review. Nonetheless, due to the efforts of the staff at the Thousand Oaks Inn, it appears all those in attendance enjoyed the evening.

Since Americanism falls under my station I felt compelled to research some information concerning Memorial Day. I found an article on the internet which provides some historical references as well as reflections on how the holiday is regarded today. The following consists of excerpts from the article, the full text of which can be found at www.usmemorialday.org/ backgrnd.html

Memorial Day, originally called Decoration Day, is a day of remembrance for those who have died in our nation's service. While Waterloo N.Y. was officially declared the birthplace of Memorial Day by President Lyndon Johnson in May 1966, it's difficult to prove conclusively the origins of the day. It is more likely that it had many separate beginnings that culminated in Gen. Logan giving his official proclamation in 1868. It is not important who was the very first, what is important is that Memorial Day was established. Memorial Day is not about division. It is about reconciliation; it is about coming together to honor those who gave their all.

Memorial Day was officially proclaimed on 5 May 1868 by General John Logan, national commander of the Grand Army of the Republic, in his General Order No. 11, and was first observed on 30 May 1868, when flowers were placed on the graves of Union and Confederate soldiers at Arlington National Cemetery. The first state to officially recognize the holiday was New York in 1873. By 1890 it was recognized by all of the northern states. The South refused to acknowledge the day, honoring their dead on separate days until after World War I (when the holiday changed from honoring just those who died fighting in the Civil War to honoring Americans who died fighting in any war). It is now celebrated in almost every State on the last Monday in May (passed by Congress with the National Holiday Act of 1971 (P.L. 90 - 363) to ensure a three day weekend for Federal holidays), though several southern states have an additional separate day for honoring the Confederate war dead.

Traditional observance of Memorial Day has diminished over the years. Many Americans nowadays have forgotten the meaning and traditions of Memorial Day. At many cemeteries, the graves of the fallen are increasingly ignored, neglected. Most people no longer remember the proper flag etiquette for the day. While there are towns and cities that still hold Memorial Day parades, many have not held a parade in decades. Some people think the day is for honoring any and all dead, and not just those fallen in service to our country.

To help re-educate and remind Americans of the true meaning of Memorial Day, the "National Moment of Remembrance" resolution was passed on Dec 2000 which asks that at 3 p.m. local time, for all Americans "To voluntarily and informally observe in their own way a Moment of remembrance and respect, pausing from whatever they are doing for a moment of silence or listening to 'Taps."

The Moment of Remembrance is a step in the right direction to returning the meaning back to the day. What is needed is a full return to the original day of observance. Set aside one day out of the year for the nation to get together to remember, reflect and honor those who have given their all in service to their country.

Many feel that when Congress made the day into a threeday weekend with the National Holiday Act of 1971, it made it all the easier for people to be distracted from the spirit and meaning of the day. As the VFW stated in its 2002 Memorial Day address: "Changing the date merely to create three-day weekends has undermined the very meaning of the day. No doubt, this has contributed greatly to the general public's nonchalant observance of Memorial Day."

On January 19, 1999 Senator Inouye introduced bill S 189 to the Senate which proposes to restore the traditional day of observance of Memorial Day back to May 30th instead of "the last Monday in May". On April 19, 1999 Representative Gibbons introduced the bill to the House (H.R. 1474). The bills were referred to Committee. There have been no further developments.
