I personally refer to ENF as the "Elks Helping Hand". From your donations, ENF provides money for Scholarships, Drug Awareness programs, Youth Activities, Veterans programs, Elks Community projects and General community projects. These funds are made available to the State Association and to the Lodges. At the Lodge level money is provided as Grants. A lodge has to request and justify to Grand Lodge ENF Programs Appropriations as to how the money is to be used in order to receive a Grant. Money is available for our Elks projects all you have to do is ask for a Grant! They look at lodge per capita donations when they review requested grants. A lodge can get back more money then they donated!

An often overlooked scholarship is known as an Emergency Educational Grant (EEG). The EEG was created to help families where a parent is deceased or has become totally disabled and their student is in financial need to continue their college education.

B. S. A. HISTORY

David Naccarato, PER

For the past Antlers I've been printing some of the history of the lodge. Scouting is a big part of our Lodge and in Elkdom. Scouting is celebrating their 100th anniversary. Here is some Scouting history:

- *1905 Daniel Carter Beard created a program called the Son's of Daniel Boone. He had from 2,000 to 20,000 boys joining and organized themselves into "forts" or now known as "troops" or "dens"
- * 1908, Baden Powell published "Scouting for Boys" and formally launch the Boy Scout Movement.
- *Around 1902 Ernest Thompson Seton started the "Woodcraft Indians" and over 8 years 100,000 to 200,000 boys joined the group.
- * 1906 Ernest Thompson met Daniel Carter in London and to make a long story short they put their heads together and came up with the Boy Scouts of America. Seton becomes Chief Scout while Beard and others became National Scout Commissioners.
- * Feb.8 1910 William D. Boyce incorporates the Boy Scouts of America.
- *1911 34 year old Washington, D. C. attorney James West becomes the first Chief Scout Executive.
- *1911 BSA publishes 300,000 copies of the first edition of the "Handbook for Boys"
- *1912 Arthur R. Eldred of Troop 1 in Oceanside, NY becomes the first Eagle Scout.
- *1912 Sea Scouting is established to serve older Scouts interested in boating.
- *1912 BSA purchases Boy's Life Magazine, which had been started a year earlier by George S. Barton of Massachusetts.
- *1913 Norman Rockwell is hired as an illustrator for Boy's Life
- *1913 Scouting magazine debuts
- *1913 registration of Scouts begins; the annual fee is 25 cents
- *1913 The U.S. Congress votes unanimously to give the BSA a federal charter. Scouting publishes the first 57 merit badge pamphlets containing topics such as camping, conservation, invention, and automobiling.
- *1917-1918 In support of the war effort, Scouts plant 12,000 victory gardens, sell more than \$355 million in liberty loan bonds and war saving stamps, collect 100 railroad cars of nut hulls and peach pits for gas-mask manufacture. Rotary International becomes the first service club to sponsor Boy Scout Troops.
- *1919 President Woodrow Wilson establishes National Boy Scout Week.
- *1920 The BSA send 301 Scouts to the first world Scout Jamboree in England where they join Scouts from 33 other countries.

*1923 The Hibbing Area Council in Minnesota begins organizing canoe trips into the boundary waters along the U.S.-Canada border that evolve into the Northern Tier High Adventure Program.

*1924 Scouts with physical disabilities earn the first achievement badges that take their disabilities into account, offering then a separate path to the first Class rank. Norman Rockwell paints the first of his Boy Scout calendars, showing a uniformed scout bandaging a puppy's leg.

*1925 Membership in the BSA tops 1 million.

*1926 The first Buffalo awards are presented for distinguished service to youth. Receipts include Powell, Beard and Boyce.

Our Lodge has a mascot the Purple Pig. We also have a resident cat that keeps the mouse population down to a minimum. The cat's name is "Dork"

Now don't get me wrong this cat is unlike any cat I've seen but let me tell you about this cat.

This cat sleeps about 20 hours a day. His food is prepared for him. He can eat whenever he wants 24/7.

His meals are provided at no cost. He visits the Doctor once a year for his check up, and again during the year if any medical needs arise.

For this he pays nothing, and nothing is required of him.

He lives in a nice neighborhood in a house that is much larger than he needs, but he is not required to do any upkeep.

If he makes a mess, someone else cleans it up.

He has his choice of luxurious places to sleep. Like Terry's bed

He receives these accommodations absolutely free.

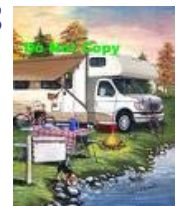

The Order of Elks was formally organized on February 16, 1868, in the City of New York. Its full corporate name is "Benevolent and Protective Order of Elks of the United States of America." Its declared purposes are to practice its four cardinal virtues, Charity, Justice, Brotherly Love and Fidelity; to promote the welfare and enhance the happiness of its members; to quicken the spirit of American patriotism; and to cultivate good fellowship.

The animal from which the Order took its name was chosen because a number of its attributes were deemed typical of those to be cultivated by members of the fraternity. The elk is distinctively an American animal. It habitually lives in herds. The largest of our native quadrupeds, it is yet fleet of foot and graceful in movement. It is quick and keen of perception; and while it is usually gentle and even timorous, it is strong and valiant in defense of its own.

A representation of the majestic head of the male, with its spreading antlers, was adopted as the first badge of the Order, and is still the most conspicuous element of its copyrighted fraternal emblem

We all know the value of volunteering for any organization, and Thousand Oaks Elks are "top cabin" in that area. We are grateful for all of you that have given your time and talent for events and projects throughout the year. We would not be able to provide activities and give to charities if you were not active members of our Elk family for the past 38 years

Our members have willingly put in many hours to activities so we could raise money for our charities. Elks National Foundation and the Major Project are the biggest charities we fund. Plus we raise money at the Charity Ball to fund our Christmas Cheer Program. 


