This article begins with what I experienced at the Grand Lodge Convention in Phoenix, Arizona. The opening ceremonies, held in a huge convention hall with thousands in attendance Sunday evening, were very patriotic. There were a lot of who's who introductions of Past Grand Exalted Rulers and their wives. That took awhile, but as they were introduced I could not help but sit in awe of the fact that these men had achieved something so unique, so noble and yet so unsung. They are members of subordinate lodges the same as you and I, but have distinguished themselves as national leaders of a benevolent society dedicated to one thing; helping those in need. I then realized why we took the time to recognize their presence.

The ceremonies continued with a parade of state flags, carried by each state association president or their designate, beginning with the first state admitted to the Union to the last. Then each branch of our military was represented with their flags. The most touching was the POW/MIA flag reverently carried down the center isle and placed upon the stage. And, of course, Old Glory was the finale of the procession with the organist playing the Star Spangled Banner in the background as the members began to crescendo singing the words to the same.

Michael F. Smith, the outgoing GER, addressed the convention with a message urging us as members to get the word out about Elks. A study examining charitable organizations found that the BPOE was the second most *unknown* of such organizations. This is not a distinction of honor by any stretch of the imagination. His position was to stop being so overwhelmed with manuals (reading them and writing them), but to start focusing on talking up Elkdom.

He wanted us to let our neighbors know what it is that we as a benevolent organization do in their community and how they can be a part of that honorable effort. Show them how the strength of our dollar is most effective as opposed to other organizations with top heavy administrative costs. Explain how our Major Projects work; employing case workers rather that outsourcing to a third party entity. Boast about how they are sent out to help families with children who have special needs. And don't forget our support of Veterans. Talk it up. Americans love to help others in need. It's who we are, who we have always been and will continue to be, God willing, into the future.

What followed over the next several days was meetings, meetings and more meetings. Then questions, answers and debate on 36 resolutions; culminating with the vote. I briefly reviewed the results of the voting in our last meeting in August. If anyone has specific questions I will by happy to address them. I will have the resolutions and voting results with me throughout the month of September.

David was born and raised in the Village of Port Henry, a hamlet in the town of Moriah. New York. Following his high school graduation in 1960, he successfully completed a four-year New York State accredited Industrial Electronics Apprenticeship training course in addition to several college-level courses and seminars in business, advanced writing, advanced math, computerized

electronic control systems, power distribution and controls, labor-management auditing and finance, workplace health and safety, and IRS and State Attorney General Tax Exempt Charities Symposiums. David spent his thirty-seven-year career in industrial electronics and safety and retired from International Paper in Ticonderoga, New York, in 1999.

David was initiated into Whitehall, New York Lodge No. 1491 in February 1975. He immediately became active with the Youth Activities Committee and served as the Lodge Organist and Chaplain. He transferred his membership to the Ticonderoga, New York Lodge after moving to nearby Crown Point in 1978. Here, he served as Lodge Chaplain, Esquire, and Organist and was active on many committees and fundraising activities. He proceeded through the chairs and served as Exalted Ruler in 1989, PER Association Chairman in 1990, and Lodge Trustee from 1988 to 2005. He served as Lodge Editor and Public Relations Chairman from 1988 to 2004 and was District Editor and Public Relations Chairman from 1993 to 1996.

David served the New York State Elks Association as State Vice President in 1990–1991, as Community Activities Chairman from 1995 to 1997, as State Editor from 1997 to 2002, as State Secretary from 1999 to 2009, and as State President in 2009–2010. He introduced the Dictionary Project to the New York State Elks Association in September 2003.

David served the Grand Lodge as District Deputy in 1994–1995, as a member of a Grand Lodge Steering Committee, as Trustee Chairman overseeing the financial assets of a defunct Lodge from 2002 to 2010, and as a member of the Board of Grand Trustees from 2006 to 2010. He introduced the Dictionary Project to the Grand Lodge in July 2004.

David has served as a member or officer of several conservation organizations and has served on the hospital board, school board, and board of fire commissioners. He is also a member of the volunteer fire company, Kiwanis Club, Knights of Columbus, Jaycees, US Coast Guard auxiliary, and is a founding

member of the Department of Homeland Security. In 2008, David was awarded President Bush's USA Freedom Corps Volunteer Service Award by then GER Paul Helsel.

David and his wife, Penny, have four children: David, who lives in Skiatook, Oklahoma, with his wife, Kim, and son Branden; John, who lives in Whitehall, New York, with his wife, Ann, and sons John Jr., Jordan, Anthony, and Austin; Lisa, who lives in Addison, Vermont, with her husband, Tim Davis, and their sons Timothy and Michael; and Claire, who lives in Sherman Oaks, California, with her husband, Charles Butterworth, and their daughter, Willow.

David and Penny are active in their church, Sacred Heart Church of Crown Point, NY, where Penny serves as a member of the choir and David serves as choir accompanist.

David believes strongly that "Elks Give from the Heart" because Elkdom, like patriotism, is in the hearts and souls of our members

Haircuts, showers, clothing, shoes, food and beds were available to all, in addition to psychiatric assistance and finding jobs. The EDD working with veterans are very active.

The Ventura County Elks Lodges combined to provide 200 brown bag lunches and playing cards for veterans on their way out Sunday. Also, the T.O. VFW and T.O. Elks provided cigarettes; not trying to encourage smoking, but revival was not the purpose.

The V.A. – Homeless division provided a bus to SLO, Santa Maria and Lompoc with no takers; very disappointing. The DAV provided vans from WLA, Lancaster, Sepulveda and Simi Valley. The Oxnard Family Center provided a 20-passenger bus to SB on Friday and locally on Sunday. The Cal Vet Home-Ventura provided two vans on Friday and the Fillmore VFW provided an SUV for the weekend that was used more than once for hospital runs.

OUR HISTORY IN SEPTEMBER 1987 & 2005

September 1st 1939- Germany invades Poland WWII begins 2nd 1945- Japan signs the formal surrender agreement on board the USS Missouri in Tokyo Bay

3rd 1939- Britain, France, Australia and New Zealand declare war on Germany 1943 British Troops land on mainland Italy, beginning the Allied Campaign in Italy. American troops land six days later

8th 1944- USSR invades Bulgaria. Germany launches the first v-2 flying bomb on Britain.

9th 1944- Bulgaria makes peace with the USSR, then declares war on Germany.

10th 1939- Canada declares war on Germany. 1943 German troops occupy Rome. Mussolini soon declares himself head of a new fascist Italian government in German occupied Northern Italy.

11th 1944- Allied troops enter Germany.

15th- Germany begins the siege of Leningrad. It would not end until January 1944

17th 1939- The USSR invades eastern Poland- 1944 Allied airborne assault in Holland

18th 1947- Birthday of the Air force POW/MIA Recognition

27th 1939- Poland surrenders to Germany 1940 Germany, Italy, and Japan sign the Tripartite Pact, making Japan part of the Axis 29th 1938- Germany, Britain, France and Italy sign the Munich Pact allowing Germany to invade the Sudeten of Czechoslovakia

Following victory at Midway, US forces in the Pacific would begin a long bloody campaign of taking the islands at the periphery of the Japanese Empire, and tightening the noose on Japan itself. Tough Battles over the next several years would be the norm, as the Allies inched closer to the heart of the empire. Guadalcanal, Tarawa, Saipan, Guam, Tinian-all U.S. victories, but at a cost.
