



David Naccarato, PER OUR BEGININGS

OK, where were we last month??. Oh yeah, the stage was set for expansion of the Elks. The most intriguing fact about the Elks between 1880 and 1890 was the growth of the organization. Our order went from 10 Lodges in major metropolitan centers and 1,000 members to 158 Lodges with a membership of 13,000.

This expansion did not just take off in major cities. Charters were being issued to smaller towns such as Peoria Lodge #20, Utica Lodge #33 and Fond Du Lac, Wisconsin Lodge #57. Have you ever heard of Fon Du Lac Ws.? (This is how I find out if anyone reads the Antler by all the phone calls I receive). Elk Lodges soon started to dot across America with a hand full in California. We were indeed becoming known as the truly American order...except for one small detail. With respect to Vivian and the half dozen English born Jolly Corks, who were credited with Elkdom's birth, a few American members wanted the Order open only to U.S. citizens. There should not be a Grandfather clause for the English born members.

This organization started in America. They chose the American elk as its symbol. Up to this point, it had not been put in writing that a member must be an American citizen. This caused such a resultant clamor throughout the order that in quick action at the Grand Convention in 1890 in Cleveland Ohio, closed this perplexing gap in our regulations. The question of Elkdom being an American order was settled forever after Grand Lodge secured a Congressional Charter. This proved difficult to get at the time. It was found that incorporation by the District of Columbia served the same purpose, the B.P.O.E. of the United States of America was thus incorporated in 1895. It did not belong to any one state, but it belonged to an entire nation. Elks were all members of one great American middle and upper class.

This was one of most obvious reasons why the Elks were founded as a charitable organization. Only charitable societies could be supported by a reasonably "well off" membership. At the conception of the Jolly Corks, they raised money through theatrical events. Change came when more doctors, lawyers, and blue-collar workers became members. They didn't have this way of earning money by theatrical events. They contributed when asked. The first recorded instance of a nationwide Elks effort was the assistance provided to the unfortunate people hurt or damaged by the Johnstown flood. In this action every lodge everywhere joined the cause. It was a far cry from raising funds to bury an Elk, or to aid his widow or orphans. The raising of disaster relief on a national level when the Elks numbers were still small, became nationally significant and showed the order was not only thinking of Elks. They were also American terms.

The Elks were the first fraternal group to do this on a national scale. From 1889 onward Elks assisted in virtually in every national disaster, and in dozens of small-localized disasters, such as fires or tornadoes, where fellow citizens



suffered. In 1906, The Grand Exalted Ruler directed Elks assistance operations- both money and volunteer labor- on the site of the terrible San Francisco earthquake and fire. Elks contributed a total of \$109,140.60 to the people of San Francisco. According to the Governor of California, the Elks were the first organization to help in San Francisco. Elks were arranging shelter for refugees within twelve hours. Elks food wagons were the first in the stricken city, preceding the Red Cross and all other organizations, both private and government. Because the Elks on a national level were ready and organized it impressed government officials and others. It created more growth.

To open your own lodge in your town was easy in the early years. Thus many rowdy lodges began to spring up. Grand Lodge finally made a requirement, no new lodge could be created without the backing of at least 25 persons of known reputation and good character in the community. This was especially important when charters began to be granted to lodges in towns of 5000 or more people. The Elk image was preserved. Before 1900, it was already a very good one. The growth in these years reached 1264 lodges and 428,479 members in 1914.

At this point the Elks came up with membership cards that showed paid-up status and where they were initiated. Demit procedures were put into place. Elkdom was rapidly growing and began to have nationwide significance. The order was still deeply committed to its members. The organization responded to all disasters, which shows a clearly national conscience. Elks were no longer concerned only with their own, but with all America... Next month what happened to Vivian, Elks and Flag Day and Elks aid in the forthcoming WWI, WWII. See you next month

Did you Know?

- Last year the Elks provided contributions for charitable works of cash, non-cash, hours worked and miles traveled in the amount of \$38,900,931 in California-Hawaii and over \$306,662,378 nationally.
- Over \$3.4 million in college scholarships is awarded annually by the Elks.
