

As Elks we know, "charity is the greatest of all the virtues and that it should ever rule us in our hearts and in our lives."It will be over the next two months that we as Elks will be most challenged to open our hearts and live up to the charitable tasks we undertake every year at this time. Of course, I am referring to our major local fund raiser, the Charity Ball, and our major local charity event, the delivery of food and gift baskets to families in need. I say challenging simple because these two events require the involvement of every Elk at a variety of levels. I should also point out that without the extensive involvement of our newer members these events could be in jeopardy. We have mostly relied on the same members year in and year out. It's time to begin passing the torch, one match at a time. This year I have been blessed with a collection of committee members who are making my experience with the management of these events more of a learning experience than one of managing. Their support and efforts are priceless. I hope to be of some value to future Leading Knights when they are faced with this responsibility.

What am I getting at? **WE NEED VOLUNTEERS!!!!** As I mentioned, participation of every member is needed at some level. Some are out of state. We've created a special raffle prize just for them. Or they can donate a prize to be raffled. Either way, they are involved.

For those right here in So. Cal. bodies, bodies, bodies. We need hands. Let me begin by giving you some dates. The Charity Ball a.k.a. "The Ball in the Fall" will be on Saturday November 13<sup>th</sup>. The charity baskets will be delivered on the Saturday before Christmas December 18<sup>th</sup>. These events require preparation. The Ball in the Fall will need help decorating and setting up tables, clean up the day after so the Sunday breakfast will not be delayed.

The biggest volunteer effort will be for the basket delivery. Preparation for this event is daunting. Everything will be based on a families list which I am currently acquiring from local charities. Volunteers will be needed for creating a staging area which involves organizing tables, and numbering them based on the list; assembling and taping the boxes used to cart the food and gifts; labeling the boxes according to the list; creating delivery routes based on the list; stocking the boxes as the list indicates for each family and so on.

Prior to all of that delivery stuff we need to purchase the food. I'll get to the gifts later. Tom Hartin will be holding my hand during this process. Much of the food is purchased at the Port Hueneme Naval Base Post Exchange. Other vendors and donors are involved as well. They will be recognized for their participation when I learn of their involvement. We anticipate anywhere between 65 and 100 families receiving charity baskets. As you can imagine an average of four members per family will generate a whole lot of food. Delivery of that much food from the


Answering the call were more than 50 members and friends who attended the sit down dinner and raised over \$1,500 for this worthy charity.

The current economic climate and other factors are resulting in more lodges being audited by the IRS. As an organization that is exempt from paying income taxes ,Lodges should keep clear, accurate records of their charitable activities and document all soures of income.

Members of the Elks are reminded over and over that their lodges are for members. Guest are welcome, but a guest must be accompanied by a member, and the member must pick up the tab for his or hers guest-at the bar or dining room. When non-members pay for their own food and drink, games, and other services at the lodge, the IRS will treat such payments as taxable unrelated buisness income. In addition, selling alcohol to non-members could violate state laws govering private clubs. **2009 Government Relations Newsletter.** 

From the September Grand Lodge Newsletter, "We must always be aware of our non profit status, in keeping this commitment we must keep our doors locked and make sure we have no signage or advertising stating that we are open to the public. We must make sure any and all guests are signed in and that any purchase at the bar, you must make and when you leave the Lodge that your guest leaves with you. Taking care of these small issues can prevent a large disaster from happening within your Lodge".

A Flag Retirement Ceremony will be held at the Lodge on November 14th. We get many flags through the year and we appreciate them. We don't want flags thrown in the trash. We give them a proper retirement. Now some flags are made from nylon, probably because it's cheaper, but it is still a beautiful looking flag. When the sun and wind get to flags, they need to be retired. But nylon flags just melt and they do not make for a good show. Max Maxwell and myself took about 15 boxes of flags that we have been storing in the BBO room and separated them into nylon and non nylon flags. New member, Kevin Boyle, whose job keeps him pretty busy and he can't volunteer his time at the lodge. Nevertheless he wanted to be involved in some way. Kevin works at Pierce Brothers Cemetery and he was able to come by the lodge and pick up about 7 boxes of our nylon flags to give them a proper retirement in a crematorium. Thank you, Kevin Boyle. We're on our way to getting our BBQ room cleaned up. Please continue to bring in your old flags. In fact, I receive flags in the mail from members out of the area. That's how important the Flag Retirement Ceremony is to these people.



During the last Elk year, we went through the five-year by-law and house rule updates that are required by Grand Lodge. When I went to order more by-law books for our lodge, I was informed that we had to do a complete by-law and house rule revision. A committee was formed and updated our by-laws. After they were sent in and accepted by Judiciary, we had a motion on the floor to go to two meetings a month. The new by-law change to ArticleIV, section 1 reads, "the regular meetings of this lodge shall be held on the first and third Wednesday evenings of each month".

Unfortunately our books were already printed with them still saying first four Wednesday evenings.

I write all this to bring everyone up to speed, because we have two motions to change our by-laws once again. And the membership will need to vote on the motions.

The two motions are:

1. Motion made by Bill Sternberg member # 2098 and read on the meeting night of 10/6/2010 "Article IV, Section 1. The regular meetings of this lodge shall be on the first four Wednesday evenings in each month throughout the year. 2. Motion made by Kira Wagner member #2220 "Article IV Section 1. The regular meetings of this lodge shall be held on the first, third, and fourth Wednesday evenings in each month throughout the year. The second Wednesday will be Officers and House Committee meetings.

In both cases the fifth Wednesday will be dark.

The meeting for voting on the motions will be held on November 3rd. This is following Grand Lodge Statute Section 17.060. A Majority vote of the members at the meeting shall be required for adoption

I need to make clear that the motion that receives the most votes is what we will go with. But also in the running is leaving it the way, it is now. The ballot will have three choices



## David Naccarato, PER OUR STORY & MAJOR PROJECT

First before I get started, I'm amazed at the response I get from this history column. And I hear "no one reads the Antler". Last Month I ended with what happened to Vivian and how the Elks were involved in the World Wars and Flag Day.

Charles Vivian was a performer who made his living performing at different venues all over the United States. He returned to New York City expressly for a very special event. The Elks were holding a ball on June 8, 1868. A series of ads appeared in the New York Herald, but Charles Vivian's name was left off the programs and posters printed for the occasion. When Vivian found that he had been ignored in this manner, he was very upset and many of his friends felt the same way. A storm was brewing and at a Lodge meeting in the words of Past Grand Exalted Ruler, Detweiler, "an unseemly altercation". On June 14 a motion was made to expel Charles Vivian from that meeting. There were violent objections and the session broke up with no definite action of any kind. Vivian was unquestionably hurt and he left that night. According to the record, he never again sought entry into an Elks Lodge

Charles Vivian certainly founded the Elks and was their guiding spirit. As the Elks grew to be a serious organization, Charles Vivian's "happy-go-lucky, fly- by-nights" attitude just didn't fit. Vivian found a drastically mature organization that had grown from his fun loving brainchild, under the guiding hand of George McDonald, a legitimate actor

McDonald was described as a person of fine character who believed in rituals, rules, and regulations. He thought that was the direction the Order should take. He felt there was a tremendous future in America for such an organization. McDonald was the leader of those who foresaw a more glorious future for the Elks.

Charles Vivian tragically died at the age of 34 from pneumonia in Leadville, Colorado. Vivian's funeral was a big event. Everyone in Leadville turned out, but years later the grave was only marked by a wood plank and engraved with a nail point. But an Elk is never forgotten never forsaken. In 1889 the Board of Grand Trustees of the B.P.O.E.informed Boston Lodge #10, and they had the remains of Charles Vivian moved to Mt. Hope Cemetery in Boston. There is a magnificent monument and assured perpetual care. Also the Order took care of Vivian's widow until her death in 1931. The memory of Charles Vivian in Elkdom was secure. More important, the order he had done so much for was moving ahead out of bitterness to bigger and better things. We'll save the rest till next month.

All the lodges in the California/Hawaii Elks Association support the Purple Pig Program. You probably have noticed around the lodge, the pigs that are prominently displayed to remind you of this program. It's unfortunate that some children by no fault of their own may be born with a birth defect. For one reason or another the parents can't afford the care that the child may need. It may be due to being out of work, or not having insurance, or living in a rural area away from a metropolitan city. They may really feel that they have nowhere to turn. That is when the Elks Major Project steps in. We provide the therapists to go to the home of the disabled child and work with them in their homes. Our therapists are trained in occupational therapy, speech therapy and physical therapy. Also we have a group that travels to preschools to perform eye screenings to find eye problems early. Than we direct the parents to consult an ophthalmologist. It is estimated that about 1 in 20 children between the ages of 3 and 5 has some sort of vision problem.

The Elks Preschool Vision Screening Program screens between 45,000 to 50,000 children each year. Due to our efforts thousands of children have been saved from permanent eye damage from visual issues such as lazy eye, astigmatism, myopia and tsarisms. It is important to find these issues early, so we can direct the families toward finding appropriate medical help. We also will assist in additional financial help when needed. Our occupational therapist also works with the parents to show them what needs to be done when we are not there. Occupational therapy is learning how to dress yourself, brush your teeth, and comb your hair. It sounds simple enough; however having a disability can make an easy motion hard to do. The therapists will also show them different ways to get the job done. Physical therapy works on motor skills to exercise their muscles. Speech therapy is to help the kids with communicating and eating, to make sure they are swallowing correctly. Every child is different.

This year's Theme Child, although she is not a child now is Alexis Booth. She is now 18 years old and has been taken care of by the Elks her whole life. She now will be attending college with the help of an Elks scholarship. You can see a picture of her in our anteroom.

The goal of the program this past year was to reach the 3 million dollar mark, and this year at convention we did it with your help. I want to also inform you that less than 3% of the money raised is used for administration. The program does not take pledges, only cash. The money you give will help a child walk, talk, see and play. We help disabled children regardless of race, color, or creed using our own therapists.

Our Purple Pig would be proud to tip his hat to whatever you care to donate. Right now the organization is celebrating their 60 years of service with a special promotion. With any donation of \$60.00 you will receive a citation signed by our State President and a beautiful pin to wear proudly that you were part of a great program. I could go on, but I'll end it here- more next month.
