#### **MEET OUR NEW STATE PRESIDENT--**

Wayne Howard was born on September 27, 1934 in Gunter Texas and attended public schools in Arlington Texas. After high school Wayne entered the US Navy in 1951. His tour of duty took him to many places in the Pacific including Hawaii, Japan, Philippines, South and North Korea and China. Wayne served as a machinist mate on board his ship and was separated from active duty in 1955 to serve in the inactive naval reserve before being discharged in 1959. After Wayne was separated from the Navy he worked at several different jobs in Texas, Oregon and California efore returning to Texas where he went to work for Continental Baking Company, Wonder Bread and Hostess Cup Cakes in 1956. Wayne worked part time and returned to College majoring in Baking Science and Management from 1959 to 1962. In 1967 Wayne was asked by Continental Baking Company to move to Hawaii and manage the production department for Love's Bakery, a subsidiary of Continental Baking Company.

During his time with Love's, Wayne was active in the community as a member of the Environmental Management Association. He served two years as Secretary of the Hawaii Banana Association and two years as its President. He started his own family bakery in 1977, Ono Cones of Hawaii making ice cream cones. He sold his successful 31 year old company in 2008 and retired. Wayne was asked to join the Elks in Kailua Hawaii Lodge No. 2230 and did so on December 2, 1969. Wayne became active and started through the chairs to be elected Exalted Ruler of Kailua Elks Lodge No. 2230 in 1975. He remained active in Kailua for several years chairing several committees and was Chairman of the Trustees in

1984. Wayne became active in Honolulu Elks Lodge No. 616 and transferred his membership to Honolulu in June 1989. He served on several committees including the Auditing Committee, one year as chairman. He also was elected to Treasurer where he served for two years.


#### CALIFORNIA HAWAIIN ELKS ASSOCIATION



#### **Lodge Renovations**

Earlier this year, I was asked to chair a committee to handle Lodge Renovations. As most of you will agree, our facility is badly in need of attention. Our goal is to renovate our lodge on a cost effective basis with three goals in mind: enhance our ability to attract new members, increase revenue through the rental of the lodge room, and make our lodge more enjoyable for our members, families and guests.

A conceptual plan for remodeling the ladies bathroom, the lodge anteroom and relocating the kitchen service window was approved by the House Committee in February, and in May the House Committee gave its approval to move forward with a plan for the ladies bathroom, which will be our initial focus. We are working with a bathroom plan that is intended to be handicapped accessible. Thanks to input from Terry Gicking, Abe Gamble and Boyd Lindquist, we have a plan which we will present to contractors for the purposes of determining feasibility (it is an old building) and to solicit bids.

Once we begin the actual work on the ladies bathroom, we will determine the next phase of our project, which likely will be to renovate the anteroom and lodge room.

The BIG question, of course, is how are we going to pay for this? We are planning a series of fundraising events, the first being the Cat/Dave dinner and entertainment night scheduled on June 25<sup>th</sup>. More functions and dates will be announced shortly. We will be asking for participation in our fundraising efforts from our Lady Elks and Konejo Kampers, both of which have always made significant contributions to our lodge. Finally, as many of you are aware, the lodge holds a significant amount in its restricted building fund. We expect to ask the membership to utilize some amount of restricted funds to the extent necessary to meet our goals, subject to presenting a plan to replenish what is used and to grow the building fund on an ongoing basis. This, of course, is expected to be the subject of much debate among us, but I suggest that utilizing some amount of restricted funds to enhance the lodge for the purposes outlined above is a necessary investment in the future of this lodge, with greater potential benefit than the minimal interest rate currently earned on these funds. The ultimate desired result of this project is to grow revenue and membership to the point where we can realistically look at building a better facility. We expect this project to get us to that point.

Many thanks to Donna Leary, Steve Finnerty, David Naccarato and Sharon Baker for their contributions to the committee, and special thanks to Tom Ryder for his input and his accomplishments to date with Operation Facelift.

I welcome your input regarding this project, and I will keep you informed on our progress and fundraising efforts.

#### Have you ever wondered what happened to the 56 men who signed the Declaration of Independence?

For the record, here's a portrait of the men who pledged "our lives, our fortunes and our sacred honor" for liberty many years ago. Fifty-six men from each of the original 13 colonies signed the Declaration of Independence on July 4, 1776. Nine of the signers were immigrants, two were brothers and two were cousins. One was an orphan. The average age of a signer was 45. Benjamin Franklin was the oldest delegate at 70. The youngest was Thomas Lynch Jr. of South Carolina at 27. Eighteen of the signers were merchants or businessmen, 14 were farmers, and four were doctors. Twenty-two were lawyers - although William Hooper of North Carolina was "disbarred" when he spoke out against the king - and nine were judges. Stephen Hopkins had been governor of Rhode Island. Forty-two signers had served in their colonial legislatures. John Witherspoon of New Jersey was the only active clergyman to attend. (Indeed, he wore his pontificals to the sessions.) Almost all were Protestants. Charles Carroll of Maryland was the lone Roman Catholic. Seven of the signers were educated at Harvard, four at Yale, four at William & Mary, and three at Princeton. Witherspoon was the president of Princeton, and George Wythe was a professor at William & Mary. His students included Declaration scribe Thomas Jefferson. Seventeen signers fought in the American Revolution. Thomas Nelson was a colonel in the Second Virginia Regiment and then commanded Virginia military forces at the Battle of Yorktown. William Whipple served with the New Hampshire militia and was a commanding officer in the decisive Saratoga campaign. Oliver Wolcott led the Connecticut regiments sent for the defense of New York and commanded a brigade of militia that took part in the defeat of General Burgoyne. Caesar Rodney was a major general in the Delaware militia; John Hancock held the same rank in the Massachusetts militia. British captured five signers during the war. Edward Rutledge, Thomas Heyward, and Arthur Middleton were captured at the Battle of Charleston in 1780. George Walton was wounded and captured at the Battle of Savannah. Richard Stockton of New Jersey never recovered from his incarceration at the hands of British Loyalists. He died in 1781. Thomas McKean of Delaware wrote John Adams that he was "hunted like a fox by the enemy - compelled to remove my family five times in a few months." Abraham Clark of New Jersey had two of his sons captured by the British during the war. Eleven signers had their homes and property destroyed. Francis Lewis's New York home was razed and his wife taken prisoner. John Hart's farm and mills were destroyed when the British invaded New Jersey, and he died while fleeing capture. Carter Braxton and Nelson, both of Virginia, lent large sums of their personal fortunes to support the war effort but were never repaid. Fifteen of the signers participated in their states' constitutional conventions, and six -Roger Sherman, Robert Morris, Franklin, George Clymer, James Wilson, and George Reed - signed the U.S. Constitution. After the Revolution, 13 signers went on to become governors. Eighteen served in their state legislatures. Sixteen became state and federal judges. Seven became members of the U.S. House of Representatives. Six became U.S. senators. James Wilson and Samuel Chase became Supreme Court justices. Jefferson, Adams, and Elbridge Gerry each became vice president. Adams and Jefferson later became president. Five signers played major roles in the establishment of colleges and universities: Franklin and the University of Pennsylvania; Jefferson and the University of Virginia; Benjamin Rush and Dickinson College; Lewis Morris and New York University; and George Walton and the University of Georgia. Adams, Jefferson, and Carroll were the longest surviving signers. Adams and Jefferson both died on July 4, 1826, the 50th anniversary of the Declaration of Independence. Carroll was the last signer to die in 1832 at the age of 95. Such were the stories and sacrifices of the American Revolution. These were not wild eyed, rabblerousing ruffians. They were soft-spoken men of means and education. They had security, but they valued liberty more. Standing tall, straight, and unwavering, they pledged: "For the support of this declaration, with firm reliance on the protection of the divine providence, we mutually pledge to each other, our lives, our fortunes, and our sacred honor". They gave you and me a free and independent America. The history books never told you a lot of what happened in the Revolutionary War. We didn't just fight the British. We were British subjects at that time and we fought our own government! Some of us take these liberties so much for granted.....we shouldn't. We should respect and honor the few heroes, the true revolutionaries, who believed in liberty and freedom so much that they gave their lives and fortunes to force changes for the common good. So, take a couple of minutes while enjoying your 4th of July holiday and silently thank these patriots...



#### JULY'S MILITARY HISTORY

\*July 3, 1940- The British sink the French fleet at Oran

\*July, 1942- Japanese Troops take Guadalcanal.

\*July, 194-The U.S. occupies Iceland 1944 Japanese troops on Saipan Surrender.

\*July, 1944- The Allies liberate Caen

\*July, 1940- The Battle of Britain begins. Germany bombs Britain, and the British defend themselves from the air in what Churchill would call "their finest hour"

\*July, 1943-Over 160.000 Allied Troops land in Sicily to begin operation "Husky"

\*July 16,1945 The world's first Atomic Bomb is tested in New Mexico- the Trinity Test.

The parts of the bomb to be dropped on Japan are already on their way. In Germany, the Potsdam conference between the U.S., Britain, and the USSR begins.

\*July 20, 1944- German military leaders try to kill Adolf Hitler in the Rastenburg Assassination plot. Hitler then kills about 200 suspected plotters. U.S. troops make an amphibious assault on the Japanese held Island of Guam in the Marianas.

\*July 22, 1942- Germany begins deporting hundreds of thousands of Jews from Warsaw Ghetto to the Treblinka Concentration Camp.

\*July23,1944- U.S. Troops make an amphibious assault on the Japanese held island of Tainan in the Marianas

\*July 24, 1943- The Allies begin bombing Hamburg

\*July 25, 1943- Benito Mussolini's fascist government is overthrown in Italy. The new Italian government begins peace talks.

\*July26, 1943- The U.S., Britain and China issue the Potsdam Declaration which gives an ultimatum to Japan unconditionally surrender immediately, or face prompt and utter destruction. In Britain Clement Atlee replaces Winston Churchill as Prime Minister.

\*July 27 is Korean War Veterans Armistice Day.

\*July 29, 1921- Adolf Hitler becomes Fuhrer of the National Socialist German Workers (Nazi) Party.

\*July30, 1945- The USS Indianapolis is sunk en route to Leyte Gulf. Of the 1,196 aboard, only 316 remained alive when they were rescued from the water almost five days later. It marked the worst American Naval disaster of World War II.
