A Message From The Exalted Ruler Dan Martyn



Association Vice President Bob Alvarez's visitation was well attended by representatives of our Lodge as well as many other Lodges in our district. Bob and his wife Myrna were very appreciative of the warm reception they received, and were most complimentary to our kitchen crew and servers. Kudos to Jim Porter and his kitchen crew and Angie Porter and her servers. If I had known

that Jim had a ten pound meatloaf left, I am sure I could have auctioned it off for at least \$100 to one of our visiting Elk brothers or sisters. Thanks to Donna Leary and Kathy Moye for all of their help, and my very special thanks to my First Lady Karen, who helped me put the event together and was a terrific hostess.

Bob Alvarez's visitation included a meeting with our Lodge officers and committee chairs to review each committee's results and future plans. Our next visitation will be from DDGER Robert Schrum in October. That visitation will involve, among other things, a financial review.

While our Club and barbeque operations currently are performing at an acceptable level, a recent audit by Grand Lodge was very critical of the financial results for the kitchen. Although we have seen some recent improvement in the numbers, the bottom line is that while we do not expect a large net profit from the kitchen, we cannot afford to suffer a loss. I also emphasize that this problem is not a recent one and it isn't unique to our Lodge; many Lodges struggle with kitchen operations, and the problem at our Lodge has existed for years. Unfortunately, we can no longer dodge the issue.

Your House Committee will be reviewing kitchen operations and finances to determine what adjustments should be considered in terms of meal services and prices, and we have already decided to adjust our Sunday breakfast pricing by increasing each breakfast category (\$4-\$5-\$7) by \$1, to \$5-\$6 or \$8, depending on the meal chosen. The price for a Bloody Mary or Mimosa will also be increased by the same amount, to \$3.

In discussions regarding price increases, I have on more than one occasion been reminded that members pay dues and expect to pay less than "full retail". First, our pricing, even with recent increases, remains more than competitive. Second, dues are used to cover various administrative expenses. Dues do not cover operating expenses. Basically, the bar, kitchen and barbeque must operate profitably in order to cover the operating expenses of the Lodge including food and bar supplies, salaries, maintenance and repairs, taxes and utilities: gas, electric, etc.

I share this information with you because it has surprised me in the past that many members were uninformed about the financial realities of Lodge operations, and believed

A Message From The Secretary David Naccarato



I get asked many question through out the day. Many of which I'm sure others have the same question so I want to put them in the Antler Antics.

A member who has been dropped from the rolls for non-payment has 30 days to pay their dues and come back as if nothing has happened. After that time a member not in good standing and wants to be reinstated is treated like a brand new member except for

needing to go through the initiation. They may if they choose but it's not mandatory. We have to buy sauce, garlic salt and pepper, plastic utensils and slicer up keep. We didn't attend this event last year and we had a bad turn out at CVD last year so we are still playing catch up. The people that run the Moorpark event called and asked, no begged us to come back. They had teams who would not make the trip if we didn't bring our Tri-tip sandwiches. The Trustees has us at \$13,000 for this years CVD we did \$13,200. We brought in \$6,800 in Moorpark. On the line we had Steve McGee, Herb Jellander, Dave Anderson, Gerry Gillies, Ed Rice, Tom Hartin, Louis Reis, and Jim Mullen . Inside Faye Stevens, Christine Harrison and Bill McIntyre. I was on drink patrol outside. We also had Jill Williams team at the lodge performing at their best as normal but to throw them a curve ball(nothing is easy here) we had a special order for three hockey teams from San Diego plus a private function here at the lodge. If I missed someone I'm sorry I can always print a retraction. The bills are paid we all still have our fingers and saw some good Field Hockey action.

Broke my chair in half. I'm now in a loaner. Reminds me of a Rambler my Dad used to own.

In line at the grocery store picking up items for our "New kids on the block" breakfast the lady in front of me asked for plastic bags. The cashier mentioned the she should think about bringing her own bags

because plastic bags are not good for the environment. The lady apologized and said "we didn't have the green thing back in my day" the cashier said "that's our problem today. The former generation did not try to save our environment".

I thought about that a minute. I remember returning milk, soda and beer bottles to the store to be washed and reused. That's the same bottle not a new one. *Really* recycled. Back in the day kids rode their bikes to school or took a streetcar instead of turning to their Mom for a ride to school. There was one outlet in a room instead of a whole bank of outlets to power a dozen appliances. We didn't need a computerized gadget to receive a signal beamed from satellites 2000 miles out in space in order to find the nearest pizza joint. Isn't it sad that the currant generation laments how wasteful the old generation were just because they didn't have the green thing back then?


