

Attendance at the general meetings has recently been very low so I thought that explaining one of the incentives for you to attend might help.

A Capsule Drawing takes place at each general meeting. The capsule is a small plastic container which contains the name and number of each currently paid-up member of the Lodge. The capsules are all contained in a tumbler which is turned to mix the capsules and ensure a random drawing.

The member named in the winning capsule must be a paid-up member of the Lodge, must be present at the general meeting, and must have purchased \$5 worth of tickets for the Good of the Order raffle.

The Capsule Drawing begins with an amount of \$25 and each time there is no winner \$25 is added to the raffle amount until it reaches \$500. Once we reach \$500, a second capsule drawing is started in the amount of \$25 and continues to be increased by \$25 each meeting until there is a winner or the raffle amount again reaches \$500 and a new capsule drawing begins.

So far this year we have drawn the names of ten members, who would have won if they had been present. At the last meeting, Darryl (Duke) Kopacz won \$500, but we are already up to \$350 on the remaining capsule drawing which increases at each meeting.

I encourage each of you to attend meetings. Not only may you enjoy a financial benefit, but you may also enjoy being involved in decision making and Lodge Operations. And, sometimes, the meetings are even a bit of fun.

Most Valuable Student Scholarships

Applications for the 2016 contest will be available for download at www.elks.org/enf/scholars/mvs.cfm in September, 2015. During the past year, 500 four-year scholarships, ranging from \$1,000 per year to \$12,500 per year were awarded nationwide for graduating high school seniors based on scholarship, leadership, and financial need. Any high school senior who is a citizen of the United States is eligible to apply. Applicants need not be related to a member of the Elks. California and Hawaii students were also eligible for additional awards made at the District and Association levels. Applications will be turned in to the local lodges. Deadline this year will probably be December 4, 2015.

Legacy Awards

250 college scholarships (\$1,000 per year) for children and grandchildren of Elk members in good standing. Applicants compete against other children and grandchildren from the state of their sponsoring Lodge. Applications will be online for the 2015-16 year at www.elks.org/enf/scholars. They are judged on core values of ENF: Knowledge, Charity, Community Service, and Integrity. Applications must be submitted online by Jan. 30, 2016.

Emergency Educational Grants

One-year, renewable educational grants available to children of deceased or totally disabled Elks. They are grants of up to \$4,000. Applications will be available May 1, 2015 and are due October 31, 2015. Complete details are available at www.elks.org/ENF/scholars/eefgrants.cfm.

Vocational Grants (Occupational or Technical Training)

This program has recently been revised to increase the amount of the awards and to make it more flexible. The website information has been updated since the MidTerm Convention last November.

Grants of up to \$2,000 are awarded in California and Hawaii. The grants are for one year, with an option to renew for one additional year. Applicants must be planning to pursue a full-time vocational or technical course above high school level. The purpose of the grant is to assist students to become gainfully employed in their chosen vocational career with less than two years of study. High School diploma or GED is not required. Students enrolling in courses less than a year in length may be eligible for a partial grant.

The program is open to any American citizen who requires training or retraining to compete in the workplace. It is not limited to high school students and applications may be turned in at any time.

The grant may be used for tuition and fees, room and board if living on campus, and books and supplies. It may be used only for usual and required costs of student's course of study. **Grants can only be paid to the school and may NOT be paid after training is already completed.** Applications are online at www.chea-elks.org (Click on Youth Activities, then select Scholarships and scroll down)

California-Hawaii Elks Major Project, Inc. Undergraduate Scholarship Program for Students with Disabilities

Since 1981 the Elks have provided financial assistance to students with severe disabilities wishing to further their education.

This program is a financial needs based and academic use scholarship. It may be used for undergraduate work at an accredited community college, a four year college, university, or licensed vocational school. The funds cover academic expenses only, which includes tuition, books, lab fees and on-campus room and board. Applications are online at www.chea-elks.org.
