#### **Ratification of Constitutional Amendments**

At the Grand Lodge Convention in Houston, Texas held July 3rd thru 6th, 2016, four amendments to the constitution were voted on and require lodge verification. At the general meeting to be held September 7th, lodge members in attendance will vote on the following:

- 2016-02 To eliminate any responsibility for the Elks National Home given it's resent sale.
- 2. 2016-05 To clarify that Lodge trust and other related legal entities are subject to the applicable provisions of section 16.030 of the laws of the order.
- 3. 2016-07 To provide local lodges with memberships of 99 or less only require seven members to constitute a quorum.
- 4. 2-16-09 To clarify that elected trustees of a lodge shall not be less than three (3) nor more than five (5)



What starts out in a mouth, ends up on your tie. In most cases it's soup or another part of your diet. What I am speaking about is the Elk's tooth.

In many cases, an Elk's tooth was given as a token of appreciation by a grateful lodge, or bestowed by a proud Elk father on his son at his initiation. Given the strong emphasis on "always carry your cork" by the Jolly Corks, it is almost certain that on day one of the Elks, a similar practice was adopted with the Elk's tooth. It would be many years before the advent of the membership card and many parts of the elk were used until the tooth was settled upon by members.

There are variations with the Elk's tooth; front, doubles and molars. At lodge gatherings the tooth became an instant conversation piece.

Once you acquire an Elk's tooth, you might just enjoy wearing it or trace it's history from inscriptions or information obtained from the seller. You can find them at on-line auctions such as E-Bay. Due to the hundreds of jewelers that were involved in the manufacturing of these "fraternal calcium oddities",trying to track it's origin may be a case of "biting off more than you can chew!!"

#### Elks Colors

The Elk colors are Royal Purple and White, a combination deriving it's origin from history of the Clergy, Nobility, and the People. Throughout Europe, the Orient and Rome the symbolism of colors was associated with severity of laws and customs.

Each color in each pattern was identified as religious, or political, and to change or alter the flag was a crime of rebellion, a desertion of principle, party or cause. With the Elks logo: White denotes purity and absolute truth. When combined with Royal Purple it signifies the love of truth and the highest degree of Virtue. Purple is the badge of Kingship, the color of the robes of Emperors and high priest, and signifies highest favor.

Blending of White and Royal Purple indicates the favor of the people, which bespeaks the statues of Elkdom.

Sepulveda VA and to the Karaoke team, Robert Jones, Lori Hartin and Marlene Nord who kept that service going in July. Four months of planning and preparation, then three days of service, hard work and comraderie at the Army National Guard Armory and the 24<sup>th</sup> annual Ventura County Stand Down is complete. There is still much administrative follow-up to do and then the November 6th Annual Veterans Brunch comes to the lodge.

Tom Hartin and his crew served more than 250 lunches on Saturday with help from bartender Krista, bar manager Brooke and Ed Rice in the kitchen, after which Krista and Ed joined Tom at the Stand Down to serve the lunches. Terry Gicking and the Elks County Crew met at the Ventura Lodge and prepared 200 bag lunches with lots-o-goodies. Costs for this and 100 cases of soda were shared with other lodges. Art Urbano helped with the transportation and performed the Sunday Religious Service. Carl was on duty for the weekend and spent a lot of time resting the following week. The Freedom Grant

provided \$500 for transportation expenses and \$500 for boots and supplies. We also shared \$300 in expenses with VFW Post

11395. Overall, we served a total of 155 veterans (140 men and 15 women), including 109 from Ventura County, 19 from LA County, 18 from Santa Barbara County and 9 from others. 24 spouses were served, for a total of 179. We used 300 volunteers to provide the services.

#### Elks National Foundation & Bequests and Living Trusts

Through the Elks National Foundation (ENF), which is the investment arm of the Elks, for every dollar we donate the Elks invest and get back \$2.70 or more. They use that money to pay for programs once they are past the local level, such as scholarships to high school seniors, free throw contest winners and Americanism essay contest winners. Once we reach the Grand Exalted Rulers goal of \$4.65 per member we can start to request money for local programs. Last year our lodge received \$3,750.00 that we used for Veterans and to help a school of Special needs Children.

What is a bequest? It is a gift by your will, usually a clause in your will, that bequests money or other property

to your heirs or selected beneficiaries, e.g. your favorite charity.

What is a Trust? It is a document in which a person (trustor) leaves property to another (Trustee) for the benefit of another during your lifetime; you have created a living trust.

What can you do? You can remember the Elks Major Project. It would pool millions of dollars available for the treatment and care of children with disabilities.

Right now a principal investment of \$10,000 will earn you 7% yearly. Checked your bank lately? Estimated income in 16.2 years \$12,245. The effective pretax rate of 7.83% **benefits you.** *Lifetime*


