



### Meet our Exalted Ruler Jean Miraglia

I was born in Brooklyn, New York, in September of '42, where my Dad worked in a foundry making castings for airplane parts. My first five years we moved to three different states. In 1944 we moved to my Mom & Dad's hometown, Trenton, New Jersey. A year later we moved to Los Angeles where I attended Kindergarten, near USC. By first grade I was back in New York. I continued my education in Brooklyn, and graduated from New Utrecht High School in 1960.

I was raised with cousins who are deaf. I became aware of another language, Sign Language. In the classroom I applied my knowledge of Sign Language as a tactile-kinesthetic approach to learning.

After high school I went on to New York University, majoring in Speech Communication. While attending NYU, I worked in Manhattan as a salesgirl in a gold and silver shop. I eventually worked for Schenley Imports on the 57<sup>th</sup> floor of the Empire State Building, where I prepared Bills of Lading and Government Strip Stamps for various Schenley liquor products coming into the New York Harbor. During this time I was dating Gregg.

We have known each other since I was 10 and he was 12. Gregg lived around the corner from me. However, we were closer than that, it was only a fence that separated our backyards. Gregg was the pesty kid that would ride his bike around the corner and spoil whatever game we were playing. Eventually, Gregg and my brother became

best friends. By the time I was 16 we started dating. We both knew this was a match. I left New York University, and we were married on August 20, 1961. We have 2 daughters, Michele and Kathleen, and 4 grandchildren, Michael, Vinny, Angela and Nicholas.

In 1967 we moved to Tarzana, California, where I continued my education. I attended Pierce College and received my AA degree in 1970. I soon transferred to California State University, Northridge (CSUN), where I had the opportunity to be trained by some of the finest professors in the Departments of Communicative Disorders and Special Education.

In 1973 I received my Bachelor of Arts in Speech, and in 1975 my Master of Arts in Communicative Disorders. By 1981 I had obtained my California State License in Speech Pathology, and National Certification in Speech Pathology, through the American Speech and Hearing Association (ASHA). I completed my fieldwork for my Master's Degree at the Crippled Children's Society in the San Fernando Valley. Seeking to learn outside of the textbooks, I placed my desire to learn outside the box in the hands of Dr. Ray Barsch and "Movigenics." "Movigenics" was his creation for learning through movement. I soon became a Speech and Language Consultant for the Ray Barsch Center for Learning.

Soon after receiving my Bachelor of Arts I applied my knowledge working for the Los Angeles Unified School District (LAUSD). I opted to pursue my profession in the classroom. The program is Federally Mandated and consists of no more than 12 students. My students ranged from grades 4 through 6. I taught all the academic subjects through a Language Based curriculum, and provided Speech and Language Therapy on a daily basis. The students I worked with had various disabilities, ranging from mild to severe. Many also had multiple disabilities, including difficulty with fine and/or gross motor skills. However, they all had one disability in common, a Language Concept Disorder. I serviced students with Cerebral Palsy, Autism, ADD/ADHD, Traumatic Brain Injury, Selective Mute, Hard of Hearing and Aphasia.

During my 34 years with LAUSD I wore many hats. For me the most important hat I wore was Administrative Designee. I was responsible for scheduling all Individual Education Plans (IEPs), 504 Plans, and parent requests for testing. My goal was to ensure the best possible placement for the student. I retired from LAUSD in 2008. Looking back on those years, I can say I had an exceptional, memorable, and enriching career.

I have been blessed. I have a wonderful, long marriage to Gregg, 55 years, 2 great daughters and 4 fantastic grandchildren. Gregg is my biggest fan and supporter. I couldn't have accomplished all of this without him.
