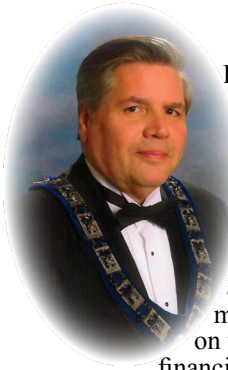
Our renovated Lodge Room is available for rental at very reasonable rates. Catering can be arranged. For more information contact Brooke at 805-496-4550.

## ***A Message from Exalted Ruler, Dan Martyn, PER***

Inasmuch as we have not had regular meetings which typically include reports on bills, receipts and bank balances, this month's article will attempt to bring our membership up to date on where things stand financially and operationally.

As you are aware, the Elk year runs from April 1 to March 31. Following our closing on March 18, the trustees revised our budget based on the assumption that during the first quarter, we would have no income other than dues, which are accrued monthly on our financials. More importantly, please keep in mind that our dues cover only office expenses, officer participation in state and regional meetings and our Grand Lodge and California state assessments. Dues do not cover any operational expenses.

With no receipts other than dues, our lodge still must pay the cost of utilities, taxes, license fees, maintenance and repairs and such. Although our lodge remains closed, our electric bill alone exceeds \$1,000 per month. It should be no surprise then that during the first quarter through June 30, our lodge suffered a loss, which was anticipated.

In June, we were able to start our barbeque operation again, after several consultations with and inspections by our Ventura County Health Department representative. Because our county has adopted very restrictive operating guidelines, even for

take-out restaurant operations, we were required to bring our barbeque operations indoors except for grilling. Needless to say, significant changes were required. I thank our barbeque crew chiefs and volunteers for working to accept and adapt to these changes. We did not hear a whole lot of the usual "we've never done it this way." Instead, our crews stepped up and did what needed to be done to stop the financial bleeding.

How has it worked out? In a word, GREAT. We have adjusted our prices to reflect increased costs. Although we operate on a take-out basis only, our receipts have exceeded our expectations, even though we estimate that we have lost between 15% and 20% of our customers because dining in our picnic area is prohibited. So, what does that mean to the lodge financially?

Well, it's good news and bad news. The good news is that we have regular income at a consistent level week to week. So, what's the bad news? Our barbeque income barely covers our current monthly operating costs by a slim margin. What does this mean? It means we are watching every penny to make sure we avoid any expense not absolutely necessary.

What's next? We continue to monitor state and county COVID-19 orders in the hope that some restrictions will be eased. Presently, indoor restaurants and bar operations are prohibited, and outdoor operations require social distancing and food service with any alcoholic beverage. Our staffing for outdoor service would require bartenders, servers, sanitizing by table cleaners and other staffing. It is not

an easy task to plan to operate within current Ventura County guidelines given our physical layout, staffing requirements and the need to conduct operations without taking a loss. As stated above, our barbeque income (net after sales tax, food costs and supplies) barely covers our current monthly bills. That income is not enough to subsidize limited bar and kitchen operations.

To sum up, we are now operating without a monthly loss, we have adequate working capital and we have not (and we will not) invade our restricted funds which are to be used solely for our community service and charitable works. Notwithstanding the present COVID-19 pandemic and its physical, social and economic impact on all of us, our lodge remains in a good financial position. We are working on alternative plans for Veteran's Day, the annual Memorial Service, our Christmas Tree Lot, as well as our annual Charity Basket Program. Your officers will continue to work toward normalizing our operations to the extent possible, given current restrictions, our responsibility for the lodge's finances and, most importantly, our concern for the safety of our members.

I apologize for the length of this "state of the union" message, but it is our responsibility as officers to keep members informed. If you have any questions, please do not hesitate to contact me at [danmartyn2477@aol.com](mailto:danmartyn2477@aol.com).

## ***A Message from Esteemed Leading Knight, Richard Platt***

We are five months into this Elk year. Hopefully, we will be able to open soon. The Ventura County Health Department has a directive mandating that bars cannot operate indoors and must serve a meal when one orders drinks outdoors. We are looking for

the right answers for your Lodge. We will continue to look into options and keep you informed. We are planning to install a fence in the patio area, which has been funded by our Kampers, in order to facilitate outdoor service.

We have been informed that the Mid-Term Convention has been cancelled. David Naccarato was able to obtain a Grand Lodge Spotlight Grant for community assistance during the present COVID-19

pandemic. Last week that check was given to Thousand Oaks Manna. We also held a blood drive in July in support of the ongoing community COVID-19 fight.

I had the opportunity to participate in the Grand Lodge's Drug Awareness Webinar. This is one of the classes that are usually presented at the National Convention. I heard from the DEA agent who was the recipient of the Enrique Camarena Award and who was instrumental in bringing the Elks Drug Awareness Program into a meaningful relationship with the DEA. In addition, Special Agent Sean Fearn, who is the Demand Reduction Coordinator at the Drug Enforcement Administration Headquarters in Washington DC, informed us about the latest and growing drug trends in the USA.

We also learned about the latest Elk video being produced by Robert Sabouni, who has produced our Elk comic books and

award-winning videos. We previewed the winning contest video prepared by a high school student, whose family was and is still fighting prescription drug abuse. One bit of information that stood out to me is that there are now more legal marijuana outlets than McDonald's and Starbucks in California. Law enforcement believes that California's marijuana growers sell about one-fifth of the total marijuana crop to legal vendors, which means there is still big money in weed on the black market, and far more crime.

successful event. Thank you for your understanding. We WILL plan for a future date.

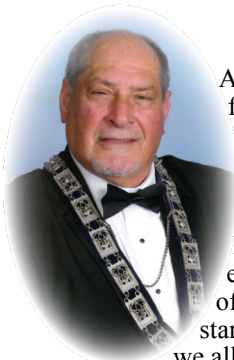
The BBQ's on Saturdays are doing great. Please share the Facebook reminders and ask your friends to do the same.

## Names on a Wall

Last month I took my two sons to visit the 9/11 memorial at the World Trade Center site in lower Manhattan. I had made many trips to the towers. Years ago between classes, Joe, my friend and study group member, and I would frequently walk to the Galway Bay, where we would enjoy cheap cold beer and NYC Irish bar style steam table sandwiches before heading back out on West Broadway, where on a cold day the wind funneling through the twin towers off the bay would chill you to the bone.

Joe was one of the nicest people you could know and loved dining and cooking, and we would frequent Little Italy and Chinatown. I remember the time we promised each other we would not discuss the bar exam after taking it, and instead had a few beers near Times Square and resisted the urge to ask each other how we thought we did.

Joe started a new job at the World Trade Center the first week of September, 2001. Until I received a notice from my school, I

did not know that Joe had been killed on 9/11, along with several other alumni. I was in New York City for my brother's wedding a couple of weeks after 9/11, and I asked the priest about the list of 30 names on the wall in the vestibule. He told me that those 30 parishioners were missing at the World Trade Center, and that there were over 200 names on the wall at the adjoining parish.

And so I went to the 9/11 memorial to pay my respects. I found Joe's name in the black granite surrounding the footprint of the North Tower, showed it to my sons and asked them to take a picture of it. As strange as this may sound, my thought when I touched Joe's name was that I hope he did not suffer.

Some time ago I took my children to the traveling Vietnam Memorial and showed them George's name, a neighborhood kid who got into some trouble in 1968 and wound up with his name on the wall. We have names on the wall at the Thousand

Oaks Library and on a monument at Westlake Blvd. and Triunfo Canyon Rd.

So what's the point? I think we should never let those words become just names on a wall. They represent the ultimate sacrifice that so many have made; some while defending our country, and some for just being Americans. It is often said that the price of freedom is high, and it is important that we make sure our children and grandchildren understand the sacrifices so many have made. When you take your kids or grandkids to Hawaii, take them to the Punchbowl Cemetery, or to the U.S.S. Arizona Memorial. If you take them to Washington, D.C., take them to the Vietnam Memorial. Show them the names on the wall.
