
Grand Exalted Ruler



The Elks have a long history of helping the community. From the Johnstown flood May 31st, 1889, to the San Francisco earthquake on April 18th, 1906. That trend continues today. Over the last two years, catastrophic disasters have ravaged many of the areas of this great nation.

Years ago, the Elks upon a vote at the Grand Lodge convention put together the "Elk's Disaster Relief Program Inc." Donations made to this program are tax deductible under the 501© (3) IRS code. Following is a list where the Elks have stepped in to help financially.

Oklahoma Tornados and Floods (\$25,000) Nebraska Floods (\$20,000) Oregon Fires (\$25,000) Texas Floods (\$25,000) Texas Climate issues (\$25,000) Tennessee Floods (\$25,000) Louisiana Floods and Hurricane (\$25,000) New Jersey Floods (\$25,000) Western Kentucky Floods and Tornado (\$25,000) Arkansas floods (\$10,000) Colorado Fires (\$25,000). Most recently, the program has provided assistance to the Montana Floods (\$25,000) and Eastern Kentucky Floods (\$10,000) to aid those in distress.

Now the order needs your assistance to replenish the program. Without support we may not be able to continue to live up to our motto "Elks care-Elks share" by easing the burden and lending a helping hand to the victims of major catastrophes. Did you know there are ways to support Elkdom by just doing what you are already doing? I am talking about Amazon Smile. If you are already an Amazon customer, the next time you order use smile. Amazon.com, search for ENF or California Hawaii Elks and a portion of your purchase will be directly donated to the charity of your choice by Amazon. Between January 1 and March 31st \$1,852.89 has been sent to ENF/CHEA from the qualifying purchases made by our members and others. A total of \$25,259.60 has been sent nationwide by Amazon Smile.

Lastly then I will leave you alone, many members are leaving California, but then want to transfer their membership to a lodge in their new area. You must be a member in good standing to transfer which simply means, paid up at your own lodge before requesting a transfer.

If it has been a few years a certificate of release may be requested for the fee of \$20 which covers the assessment paid by the lodge whether you paid your dues or not, which is \$30 so the lodge is forced to absorb \$10.



A MESSAGE FROM YOUR HOUSE COMMITTEE AND DAN HOFFMAN, COB

I can remember the days of growing up where a "Cup of Joe was 2 bits". Translation, a cup of coffee was .25 cents. Gosh times have changed, especially recently. Inflation is thru the roof. Everything we consume has increased dramatically. Gas for our vehicles, gas for our homes, water, power, home insurance, food, medical insurance, workers compensation, clothing, rentals/housing costs, etc., have all gone up substantially.

The Consumer Price Index (CPI) measures the overall change in consumer prices based on a representative basket of goods and services over time. The CPI is the most widely used measure of inflation. The widely quoted CPI is based on an index covering 93% of the U.S. population. From 2016 thru 2022, the CPI has gone up 23.44%. Just this year alone, groceries have gone up 13%.

As you can see, just "turning on the lights" at the Lodge has gone up significantly. Our Saturday BBQ continues to be the "life blood" of our Lodge. As you recall, we recently raised the costs of our BBQ products and started adding on sales tax. While some of us were worried about a possible drop in business, we have received no push back from the community and quite frankly, the general feedback was "What took you so long"?

Our Bar services and the offerings we provide have not been increased for at least 7 years. To be honest, we have been providing Bar services at a loss in the hopes that more members would support the bar and dinners. As we go thru this dilemma, we also recognize that a representative portion of our members are still hesitant to join our activities in a "closed in" environment. We are aware that we are not the only Lodge in our district being challenged by this fact. All Lodges in our district are experiencing the same challenges as is the business. For instance, Regal Theatres just recently declared bankruptcy proceedings in recognition of the current environment. All of us clearly see many local businesses raising their prices or closing operations. This is the reality in the business community today.

Therefore, it was approved at the House Committee meeting on August 17th, that the following increases in regards to the Bar services need to take place on September 1st. These increases also recognize the fact that being a member of the Elks should provide some "relief" in regard to the price of cocktails when compared to our "competitors" in our community. We embraced this model and believed the following increases support this principle. Please understand that these increases are implemented in just trying to break even. They are not instituted with an expectation of making a substantial profit. At the minimum, your House Committee cannot run the Club at a loss.

The following increases will take place on September 1st:

All domestic bottled beer will be \$4.25.

All premium bottled beer will be \$5.25.

All domestic draft beer will be \$4.50.

All premium draft beers will be \$6.00.

Champagne will be \$5.00, served via splits.

House wine will be \$5.00, served via splits.

Premium wines will be \$6.25, served via splits.

Well drinks will be \$5.00.

Call drinks will be \$6.00.

Premium drinks will be \$7.25.

Top shelf drinks will generally be \$8.00.

Drink chips will be a \$5.00 credit towards a drink. No cash value. If you order a beverage less than \$5.00, no change will be made. If you order a drink over \$5.00, you will need to make up the difference.

The costs to open the Lodge bar etc. is challenging. The membership supporting the operation of the bar has resulted in several days of the week operating at a loss. This is even in spite of the fact that we have offered dinners at \$5.00 to \$6.00 on Mondays, Tuesdays, Wednesdays and Thursdays. Therefore, effective September 1st, the Lodge will be closed on Tuesdays until further notice.

We ask you for your support in understanding the reality of running a business service in the current environment. That being said, we are committed to offering activities at the Lodge that will provide opportunities for your presence at the Lodge. As always, as we go forward, feel free to attend the scheduled meetings at your Lodge to provide your input and suggestions.
