

Sponsorship of the lodge provided by Oxnard Lodge and the Installation of Officers was held in the Thousand Oaks High School Gym with the first inaugural ball being held immediately after at the Oxnard Lodge. Both events were well attended by the Charter members and their Ladies. July 1973 we moved to our current location. With several remodels and updates we now have the facility that you know as the Thousand Oaks Elks Lodge.

#### Part 1

#### The Beginning -

The year was 1971 Richard Nixon was president of the United States, Ronald Regan was the Governor of California and Ernest Olivieri from Sonora was the California Elks State President. The West Central Coast District as we now know it was established in the 1967/68 lodge year and by 1971 consisted of seven lodges with William "Bill" Vickery the District Deputy Grand Exalted Ruler that year.

There were approximately 27,000 people living in Thousand Oaks and two high schools, Thousand Oaks High and Newbury Park High, in the local area. Westlake was being developed and their high school was just a twinkle in some ones eye. Some of our current members were not born yet.

Thousand Oaks Elks lodge's formation was the result of an innocent conversation during an afternoon get together of two men, Dick Flake and Vern McNaboe, at the Holiday Inn bar in Newbury Park. As Dick had been a member of the Garden Grove Elks lodge prior to relocating to Newbury Park and Vern a Charter Trustee of the San Fernando Lodge their conversation eventually got around to the Order of Elks.

As their conversation continued another man at the bar introduced himself and asked if there was an Elks lodge in Thousand Oaks. Dick and Vem told him no, but they wished there were one. This man then asked Dick for his name and phone number which Dick wrote down on an available cocktail napkin and gave to him. After leaving both Dick and Vem promptly forgot about the meeting.

About two weeks later after Dick got home from work his wife informed him that someone had called about starting a Lodge in the Thousand Oaks area and if he, Dick, was serious to give him a call back. It seems the person that Dick and Vern had talked to at the Holiday Inn was John Armstrong a Past Exalted Ruler (PER) of the Ventura Lodge and the West Central Coast District's New Lodge Chairman. As a result of Dick's call back to John, a dinner meeting was arranged to discuss formation of a new lodge. In attendance at this dinner was Ralph Sussmark a PER from the Canoga Park lodge and at that time the California-Hawaii Elks Association's New Lodge Chairman. Ralph and John, two dedicated Elks, outlined the problems that could and would be encountered in the start up of a new lodge. They offered to help when needed and without their help there would have been no Thousand Oaks Elks Lodge. John and Ralph at this time stated it would be necessary to name an Organizational Chairman for the undertaking and that Dick was the logical choice.

Dick met with five of his co-workers who he knew to have been Elks before and asked for their help. Bob Sauter, George Vivamore, Frank Rindone, Jon Sylcott, and Robert Jennings agreed to help and the process for establishing a new lodge was underway. Vern McNaboe was part this team.

One of the first orders of business was to obtain some working capital necessary to fund the work to be done. As Grand Lodge provides no financial help in the starting of a new lodge each of the original organizers contributed fifty dollars to an expense fund.

A start up committee was formed and furnished with a listing of "Stray Elks" in the Thousand Oaks, Newbury Park and Camarillo areas. A letter was sent to each man asking if they would be interested in establishing an Elks lodge in the area. Response to this letter was anything but overwhelming! Unfazed the committee decided to try one more time. A meeting was set for Los Robles Inn and a second letter was sent.

The time is now February 1971 and if you guessed that this was the night of the big earthquake, February 16<sup>th</sup> you were right! But who among the organizers would say the Elks lodge effort was off to a shaky beginning?

Attendance at the Los Robles meeting was not what was hoped for! But in view of the earthquake it was assumed that those that did not attend were to be dedicated Elks where family comes first and these were the kind of Elks needed to form the new lodge.

As with all lodges finances are always in question and always a constant thought. Where to get funding to continue was the question. To offset early expenses a bottle of spirits was raffled off and to show you the kind of Elks who attended were and to their resolve, this first bottle was donated back and raffled off six more times.

With this kind of support it was evident that these men could not continue meeting at Los Robles Inn.

It also became evident that someone who was better known in the community and who had resided in the community longer than most of the men doing the organizing the new lodge was needed.

Enter Erle "Doc" Pittman, a well known businessman in Thousand Oaks, agreed to become Dick Flakes co-chairman.

In an effort to lower meeting costs it was decided the new meeting place would be DuPar's Restaurant and Pub. In a short time it was decided that due to DuPar's restrictions on fund raising efforts at the meetings, a new place was needed.

John Farhat, a member of the Culver City Elks Lodge, to the rescue! He lived in the Lynn Ranch area of Thousand Oaks and as this was a horse area John had a tack room on the property. He offered this room for their use at no cost. Great! While meeting a John's, Erle and Dick continued to search for something bigger, affordable and able to be used as a full time lodge.

Dispensation was received from the Grand Lodge allowing the group to continue efforts to form a lodge in the Thousand Oaks Area. All they needed were 300 members. 300. Impossible! They finally did it with 252 men, some past/present Elks living in the area, some new members.

Meanwhile one evening Erle called Dick and stated that he had found a place that could be used and was affordable. By cigarette lighter they inspected a warehouse in the industrial area off of Skyline Drive behind what was then the Thousand Oaks Moose Lodge. The owner of the building and later to become a charter member of the lodge made an offer they couldn't refuse. They had a new home!

Phone committees were formed, lists of stray Elks were distributed and events were planned and put in motion at the new quarters. Anything to attract prospective new candidates.

The list of potential members promising to join continued to grow as did the enthusiasm of all involved.

Somewhere about now the group started a newsletter to pass information on to interested persons. This newsletter was first edited and published by Bob McGregor of Conejo Graphics

and then edited by Tommy "The Author" Thompson. This newsletter became the Antler Antics as it is know to this day.

It was a most happy day when it was announced in our newsletter, edited by Tommy "The Author" Thompson, that it was necessary for all involved to come to the lodge and sign the request for a Charter to be given to their group. 297 men signed the request and current Elks and future Elks were assured of establishment of a lodge in the Conejo Valley area.

In February 1972 the Thousand Oaks Elks Lodge was chartered and then instituted on March 25<sup>th</sup>, 1972.

Sponsorship of the Thousand Oaks lodge was provided by the Oxnard lodge. Tad DeBoni of the Oxnard Lodge was the officiating officer at the institution. Tad at this time was the District Deputy Grand Exalted Ruler representing the West Central Coast District of Elkdom.


The Institution of the Lodge, initiation of new members and installation of Officers was held in the Thousand Oaks High School gym with the first Inaugural Ball being held after immediately after installation at the Oxnard Elks Lodge. Both events well attended by our new Elks and their ladies.

The Thousand Oaks lodge was on its way and starting to grow!

In July 1973 the lodge was moved to it's current building and with several remodels and updates we now have the facility that you know as the Thousand Oaks Elks Lodge.

So here we are 52 years later with 425 Members, give or take a few. We own our building and working to increase membership. Remodeled our facility to attract members. Elkdom has changed a little with one of the biggest changes being that ladies are now allowed to be members (1995) and we do not refer to each other as My Brother(s)! but Sister.
